14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17	NEW SECTION. Section 1. Marijuana prevention account rules (1) There is a marijuana
18	prevention account in the state special revenue fund established in 17-2-102. The account consists of money
19	transferred to the account pursuant to 16-12-111.
20	
21	(2) Money in the account must be used by the department of public health and human services to
22	fund the marijuana tax revenue accountability council provided for in [section 2] and to provide grants for
23	primary substance misuse prevention and youth suicide prevention in consultation with the council
24	(3) The programs must be designed to:
25	(a) improve access to, utilization of, and engagement and retention in primary substance misuse
26	prevention services; and
27	(b) expand the availability of community-based services that reflect best practices or are evidence
28	<del>based.</del>



1	(4) The department of public health and human services shall:
2	
3	(a) manage the programs funded by the special revenue account in consultation with the
4	marijuana tax revenue accountability council provided for in [section 2];
5	(b) provide support for schools to administer the behavioral risk factor surveillance system with
6	marijuana module and the Montana prevention needs assessment for youth trends;
7	(c) adopt rules to implement the programs; and
8	(d) provide a written report to the children, families, health, and human services interim committee
9	in accordance with 5-11-210 no later than September 1 of each year on the programs, grants, and services
10	funded under this section. The report must include the amount of funding each program received.
11	
12	(5) The legislature shall appropriate money from the account provided for in this section for the
13	programs referred to in this section.
14	(6) Programs funded under this section must be funded through contracted services with service
15	<del>providers.</del>
16	
17	
18	NEW SECTION. Section 2 Marijuana tax revenue accountability council definition (1) The
19	re is a marijuana tax revenue accountability council attached to the department of public health and human
20	services for administrative purposes only as prescribed in 2-15-121.
21	(2) The council is composed of the following members:
22	
23	(a) the director of the department of public health and human services or a designee;
24	(b) a representative of the department of justice appointed by the attorney general;
25	
26	(c) a representative of the department of revenue appointed by the director of the department of
27	revenue ;
28	(d) one member who also serves on the hoard of behavioral health provided for in 2-15-1744



1	appointed by the presiding officer of the board of behavioral health;
2	
3	(e) one member who represents the behavioral health alliance of Montana and who is dually
4	licensed as an addiction counselor and as a licensed practitioner or is a master's social work licensee
5	appointed by the governor;
6	(f) one member who represents the behavioral health alliance of Montana and who is a licensed
7	psychiatrist appointed by the governor;
8	(g) one member who is a certified prevention specialist appointed by the governor; and
9	
10	(h) one public member appointed by the governor
11	
12	(3) The members provided for in subsections (2)(e) through (2)(h) shall serve 3-year terms. The
13	initial appointments may specify a shorter length of the initial term in order to stagger the terms. Vacancies
14	must be filled for the balance of an unexpired term. A member of the council may be reappointed.
15	(4) Each professional member of a board, while serving as a board member:
16	(a) must be a resident of this state and at least 18 years of age; and
17	(b) must be currently practicing in the profession or occupation and have an active license in this
18	state for at least 1 year and be in good standing for the profession or occupation in which the member is
19	appointed to serve.
20	
21	(5) (a) The public member of the council must be a resident of this state and be at least 18 years of
22	<del>age.</del>
23	
24	(b) The public member may not be:
25	(i) the spouse, parent, or child of a person who provides services or applies for a grant under
26	[section 1]; or
27	
28	(ii) a person who currently or within the 3 years prior to appointment had any material financial



1	interest in the provision of contracted services or engaged in any activity related to the marijuana industry,
2	including holding a license under Title 16, chapter 12, part 2
3	
4	(6) Each council member shall maintain eligibility to serve on the council by avoiding or disclosing
5	conflicts of interest or relationships that would interfere with the mission of the council
6	
7	(7) The council shall meet quarterly, and the director of the department of public health and human
8	services or a designee shall serve as presiding officer.
9	(8) The public members of the council shall serve without compensation but may be reimbursed as
10	provided in 2-18-501 through 2-18-503, subject to available funding.
11	(9) The council shall:
12	
13	(a) advise the department of public health and human services on the expenditures of the
14	marijuana prevention account established in [section 1] and any grants made from that account ;
15	(b) advise and make recommendations to the department of public health and human services and
16	other state agencies on primary substance misuse prevention and youth suicide prevention;
17	(c) encourage and stimulate research, public awareness, education, and prevention activities; and
18	(d) prepare the marijuana impact report provided for in [section 3].
19	(10) As used in this section, the following definitions apply:
20	(a) "Good standing" means an active license unencumbered by a final order of disciplinary action
21	or administrative suspension.
22	(b) "Primary substance misuse prevention" means preventing the initiation of substance abuse or
23	delaying the age of initiation to prevent health problems before they occur by:
24	(i) addressing risk factors;
25	(ii) enhancing resistance to those risks; and
26	(iii) shifting the focus to help people avoid, reduce, or modify drug use.
27	
28	NEW SECTION. Section 1. Marijuana impact report. The marijuana tax revenue accountability



council DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES shall provide a written marijuana impact report in
accordance with 5-11-210 to the children, families, health, and human services interim committee, the
economic affairs interim committee, and the law and justice interim committee, no later than September 1 of
each year. The report must include:

- (1) public health and safety objectives that may be impacted by marijuana policy changes, including prevalence and patterns of use; and
- (2) information on harms, including but not limited to cannabis use disorder, marijuana hospitalizations, environmental impacts of marijuana production, licenses, marijuana business density, marijuana law enforcement actions, criminal and administrative violations, youth access, and cases of driving under the influence of marijuana.

- NEW SECTION. Section 2. Marijuana law enforcement operations account. (1) There is a marijuana law enforcement operations account in the state special revenue fund established in 17-2-102. The account consists of money transferred to the account pursuant to 16-12-111.
  - (2) Money in the account must be used by the department of justice as follows:
  - (a) 99% for the marijuana law enforcement office provided for in [section 5 3]; and
- 17 (b) 1% for local marijuana law enforcement grants.
  - (3) The local marijuana law enforcement grants provided for in subsection (2)(b) must be administered by the department of justice and provided to local governments that apply for the grants. To apply for a grant, the local government must have satisfied the approval provisions contained in 16-12-301 or be located in a county in which the majority of voters voted to approve Initiative Measure No. 190 in the November 3, 2020, general election.

- NEW SECTION. Section 3. Marijuana law enforcement office. (1) There is a marijuana law enforcement office in the department of justice under the supervision and control of the attorney general.
- (2) The office shall conduct law enforcement operations related to marijuana, including but not limited to combatting black market activities and investigating and prosecuting violations of marijuana regulations.



1	(3)	The office must include:
2	(a)	two marijuana enforcement teams, one based in western Montana and one based in eastern
3	Montana;	
4	(b)	a district attorney; and
5	(c)	a canine unit.
6	(4)	The office is funded with revenue from the marijuana law enforcement operations account

    - (5) There is a fund of the enterprise fund type, as defined in 17-2-102(2)(a), for the purpose of managing state park visitor services revenue. Other fees for the use of state parks and fishing access sites, such as overnight camping fees, are still chargeable and may be collected by the department.
