A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City Public Schools – Maintenance, Preservation, and Protection of**
3 **Public Art – Requirements**

4 FOR the purpose of requiring the Baltimore City Board of School Commissioners, in
5 collaboration with the Chief Executive Officer of the Baltimore City Board of School
6 Commissioners and the Baltimore Public Art Commission, to establish and
7 implement a certain maintenance, preservation, and protection program for certain
8 public art located at certain Baltimore City public school facilities; requiring the
9 Board of School Commissioners to adopt certain regulations; defining a certain term;
10 and generally relating to public art in Baltimore City public schools.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 **4–320.**

20 **(A) (1) IN THIS SECTION, “PUBLIC ART” MEANS:**

21 **(I) AN ARCHITECTURAL ENHANCEMENT OF ARTISTIC**
22 **SIGNIFICANCE; OR**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(II) AN INDIVIDUAL PIECE OF ART.**

2 **(2) “PUBLIC ART” INCLUDES:**

3 **(I) A MURAL;**

4 **(II) A TILE MOSAIC;**

5 **(III) A PAINTING; AND**

6 **(IV) A SCULPTURE.**

7 **(B) THE BOARD, IN COLLABORATION WITH THE CHIEF EXECUTIVE**
8 **OFFICER AND THE BALTIMORE PUBLIC ART COMMISSION, SHALL ESTABLISH AND**
9 **IMPLEMENT A PROGRAM OF MAINTENANCE, PRESERVATION, AND PROTECTION FOR**
10 **THE PUBLIC ART LOCATED AT BALTIMORE CITY PUBLIC SCHOOL FACILITIES.**

11 **(C) THE BOARD SHALL ESTABLISH REGULATIONS TO IMPLEMENT THE**
12 **REQUIREMENTS OF THIS SECTION.**

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
14 1, 2017.
