A BILL ENTITLED

1 AN ACT concerning

2 **School Bus Purchasing – Zero–Emission Vehicle – Requirement**

3 FOR the purpose of requiring, beginning on a certain date, that each school bus purchased
4 by a country board of education be a zero–emission vehicle; requiring, beginning on
5 a certain date, that each school bus purchased by a certain person for use under a
6 certain contract with a county board be a zero–emission vehicle; defining a certain
7 term; and generally relating to school bus purchases.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 **7–810.**

22 **(A) IN THIS SECTION, “ZERO–EMISSION VEHICLE” HAS THE MEANING**
23 **STATED IN § 23–206.4 OF THE TRANSPORTATION ARTICLE.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(B) BEGINNING OCTOBER 1, 2023, EACH SCHOOL BUS PURCHASED BY A**
2 **COUNTY BOARD MUST BE A ZERO-EMISSION VEHICLE.**

3 **(C) BEGINNING OCTOBER 1, 2026, EACH SCHOOL BUS PURCHASED BY A**
4 **PERSON FOR USE UNDER A CONTRACT WITH A COUNTY BOARD TO PROVIDE**
5 **TRANSPORTATION SERVICES MUST BE A ZERO-EMISSION VEHICLE.**

8 (a) In this section, “zero-emission vehicle” means any vehicle that:

9 (1) Is determined by the Secretary to be of a type that does not produce
10 any tailpipe or evaporative emissions; and

11 (2) Has not been altered from the manufacturer’s original specifications.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2020.
