A BILL

- To require the Secretary of Labor to take initiatives to measure the impact of automation on the workforce in order to inform workforce development strategies, and for other purposes.

 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Workforce Data for
 - 5 Analyzing and Tracking Automation Act of 2019" or the
 - 6 "Workforce DATA Act".
 - 7 SEC. 2. DEFINITIONS.
 - 8 In this Act:

1	(1) Automation.—The term "automation"
2	means using technology to produce a good or service
3	previously produced by human work.
4	(2) BOARD; SUBCOMMITTEE.—The term
5	"Board" or "Subcommittee" means the advisory
6	board or subcommittee established or formed under
7	section 4(a).
8	(3) Secretary.—The term "Secretary" means
9	the Secretary of Labor.

2	used by the Bureau of Labor Statistics, as of the
3	date of enactment of this Act, for measuring the im-
4	pact of automation on the workforce;
5	(2) identify and review other potential data
6	sources for measuring such impact;
7	(3) identify appropriate statistical methods for
8	using and integrating other data sources to supple-
9	ment or enhance the workforce data programs de-
10	scribed in paragraph (1); and
11	(4) advise the Bureau of Labor Statistics on re-
12	search needed to acquire, evaluate, and incorporate
13	additional data sources to adequately measure and
14	assess, on an ongoing basis—
15	(A) industry sectors and occupations sig-
16	nificantly impacted by automation;
17	(B) jobs and occupations created or sub-
18	stantially changed as a result of automation;
19	(C) occupational shifts in labor demand,
20	including the number of workers displaced (or
21	with a change in earnings) due to automation,
22	and the demographics of such workers, such as
23	the race, gender, age, level of education, loca-
24	tion, employment status, and earnings of such

1	(D) the consequences of displacement due
2	to automation, including the consequences of
3	workers becoming subsequently unemployed,
4	exiting from the workforce, entering retraining,
5	changing positions within a company, and expe-
6	riencing a change in earnings;
7	(E) changes to workforce skills in demand
8	as a result of automation; and
9	(F) additional data recommended by the
10	Board or Subcommittee under section
11	4(c)(1)(A)(iii).
12	(c) Report.—Not later than 2 years after the date
13	of enactment of this Act, the Secretary shall submit to
14	Congress, and make publicly available, a report on the re-
15	sults of the study under subsection (a).
16	(d) Plan for Bureau of Labor Statistics.—Not
17	later than 1 year after the date on which the Secretary
18	submits the report to Congress under subsection (c), the
19	Secretary shall make publicly available a plan for how the
20	Bureau of Labor Statistics shall respond to the findings
21	of the study contained in such report.

1	SEC. 4. INPUT ON IMPACT OF AUTOMATION FROM WORK
2	FORCE ADVISORY BOARD OR SUB
3	COMMITTEE.
4	(a) In General.—The Secretary shall establish ar
5	advisory board, or form a subcommittee of an advisory
6	board that exists on the date of enactment of this Act
7	to provide recommendations on addressing the impact of
8	automation on the workforce.
9	(b) Membership.—The Board or Subcommittee
10	shall consist of nationally representative members, includ-
11	ing the balanced participation of—
12	(1) State boards, as defined in section 3 of the
13	Workforce Innovation and Opportunity Act (29
14	U.S.C. 3102);
15	(2) labor organizations;
16	(3) industry representatives;
17	(4) nonprofit entities, or community-based or
18	ganizations, with experience researching the impact
19	of automation on the workforce;
20	(5) academic experts in the field of workforce
21	development, labor economics, and program evalua-
22	tion; and
23	(6) any other stakeholders the Secretary deter-
24	mines appropriate.
25	(c) Duties.—

1	(1) RECOMMENDATIONS FOR ADDITIONAL
2	DATA.—
3	(A) INITIAL EVALUATION.—Not later than
4	6 months after the date of enactment of this
5	Act, the Board or Subcommittee shall—
6	(i) identify additional types of data re-
7	lated to the impact of automation on the
8	workforce that would inform actions of
9	business and labor stakeholders;
10	(ii) identify administrative data need-
11	ed to guide policy formation related to eas-
12	ing impacts of automation; and
13	(iii) for purposes of the assessment
14	under section 3(b)(4), provide rec-
15	ommendations to the Secretary and the
16	National Academies of Sciences, Engineer-
17	ing, and Medicine based on the additional
18	data identified under clauses (i) and (ii).
19	(B) ANNUAL UPDATES.—Not later than 1
20	year after the date on which the recommenda-
21	tions are provided under subparagraph (A), and
22	each year thereafter, the Board or Sub-
23	committee shall evaluate the additional data
24	identified under such subparagraph, and pro-

1	vide updated recommendations to the Secretary
2	based on such evaluation.
3	(2) Recommendations based on Bureau of
4	LABOR STATISTICS MEASUREMENTS.—
5	(A) In general.—Not later than 4 years
6	after the date of enactment of this Act, and
7	each year thereafter, the Board or Sub-
8	committee shall—
9	(i) evaluate strategies for workforce
10	development, based on measurements of
11	impact on the workforce due to automation
12	determined by the Bureau of Labor Statis-
13	tics and on other relevant evidence; and
14	(ii) provide recommendations to the
15	Secretary and to Congress based on such
16	evaluation.
17	(B) Public Access.—The Secretary shall
18	disseminate the strategies recommended under
19	subparagraph (A) to relevant stakeholders and
20	make such strategies available to the public.
21	(d) Federal Advisory Committee Act.—The
22	Federal Advisory Committee Act (5 U.S.C. App.) shall not
23	apply to the Board or Subcommittee.
