6	HEALTH RECORD TECHNOLOGY.			
7	Section $1115A(b)(2)(B)$ of the Social Security Act (			
8	$U.S.C.\ 1315a(b)(2)(B))$ is amended by adding at the expression $A(B)$			
9	the following new clause:			
10	"(xxv) Providing, for the adoption and			
11	use of certified EHR technology (as defined			
12	in section 1848(o)(4)) to improve the qual-			
13	ity and coordination of care through the			
14	electronic documentation and exchange of			
15	health information, incentive payments to			
16	behavioral health providers (such as psy-			
17	chiatric hospitals (as defined in section			
18	1861(f)), community mental health centers			
19	(as defined in section $1861(ff)(3)(B)$ ), hos-			
20	pitals that participate in a State plan			
21	under title XIX or a waiver of such plan,			
22	treatment facilities that participate in such			
23	a State plan or such a waiver, mental			
24	health or substance use disorder providers			
25	that participate in such a State plan or			

1	such a waiver, clinical psychologists (as de-
2	fined in section 1861(ii)), nurse practi-
3	tioners (as defined in section 1861(aa)(5))

5	services, and clinical social workers (as de-
