BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Education 3-902.An elected member of the county board is entitled to reimbursement for travel and other expenses as provided by the Montgomery County Council. (b) (1) An elected member of the county board is entitled to receive :

- 1 (ii) 1. Except as provided in subsubparagraph 2 of this subparagraph, the scholarship amount is equal to the highest annual resident undergraduate tuition, mandatory fees, and room and board that is charged at a 4-year public institution of higher education within the University System of Maryland, other than the University of Maryland Global Campus and University of Maryland, Baltimore Campus, for the academic year in which the student member serves on the county board:
- 7 (I) MAY BE REIMBURSED FOR OUT-OF-POCKET EXPENSES 8 INCURRED IN CONNECTION WITH OFFICIAL DUTIES; AND
- 9 (II) SHALL BE GRANTED COMPENSATION IN ACCORDANCE WITH 10 PARAGRAPH (2) OF THIS SUBSECTION.
- 11 SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE **(2) (I)** 12 COMPENSATION AMOUNT OF THE STUDENT MEMBER IS EQUAL TO THE HIGHEST ANNUAL RESIDENT UNDERGRADUATE TUITION, MANDATORY FEES, AND ROOM AND 13 14 BOARD THAT IS CHARGED AT A 4-YEAR PUBLIC INSTITUTION OF HIGHER EDUCATION 15 WITHIN THE UNIVERSITY SYSTEM OF MARYLAND, OTHER THAN THE UNIVERSITY OF MARYLAND GLOBAL CAMPUS AND UNIVERSITY OF MARYLAND, BALTIMORE 16 CAMPUS, FOR THE ACADEMIC YEAR IN WHICH THE STUDENT MEMBER SERVES ON 17 18 THE COUNTY BOARD.
- 19 (II) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS
 20 SUBPARAGRAPH, THE STUDENT MEMBER MAY ELECT TO RECEIVE COMPENSATION
 21 GRANTED UNDER THIS SUBSECTION IN MONTHLY INSTALLMENTS AS A STIPEND
 22 DURING THE STUDENT MEMBER'S TERM AND RECEIVE ANY REMAINING AMOUNT AS
 23 A SCHOLARSHIP AFTER THE END OF THE TERM.
- 24 2. The amount of a scholarship COMPENSATION granted under this subsection in any year may not exceed the amount that an elected member of the county board is entitled to receive under subsection (b) of this section in that year. PRECEIVE AS FOLLOWS:
- 28 (I) THROUGH THE TERM THAT ENDS IN 2026, A SCHOLARSHIP
 29 EQUAL TO 40% OF THE ANNUAL COMPENSATION OF AN ELECTED MEMBER OF THE
 30 COUNTY BOARD FOR THAT YEAR TO BE APPLIED TOWARD THE STUDENT'S HIGHER
 31 EDUCATION COSTS AND A ONE-TIME STIPEND EQUAL TO 10% OF THE ANNUAL
 32 COMPENSATION OF AN ELECTED MEMBER OF THE COUNTY BOARD; AND
- 33 (II) BEGINNING WITH THE TERM THAT STARTS IN 2026, A
 34 SCHOLARSHIP EQUAL TO 80% OF THE ANNUAL COMPENSATION OF AN ELECTED
 35 MEMBER OF THE COUNTY BOARD FOR THAT YEAR TO BE APPLIED TOWARD THE
 36 STUDENT'S HIGHER EDUCATION COSTS AND A ONE-TIME STIPEND EQUAL TO 20% OF
 37 THE ANNUAL COMPENSATION OF AN ELECTED MEMBER OF THE COUNTY BOARD.

SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with Article 1 2 III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 3 the salary or compensation of the president and members of the Montgomery County Board of Education while serving in a term of office beginning before the effective date of this Act, 4 but the provisions of this Act concerning the salary or compensation of the president and 5 members of the Montgomery County Board of Education shall take effect at the beginning 6 of the next following term of office. This limitation does not apply to an individual appointed 7 8 or elected after the effective date of this Act to fill out an unexpired term.

9 SECTION $\frac{3}{2}$. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 July 1, 2025.
