### A BILL

To require the Administrator of the Federal Railroad Administration to implement certain recommendations for management and collection of railroad safety data.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "FRA Safety Data Im-
- 5 provement Act".
- 6 SEC. 2. RECOMMENDATIONS FOR MANAGEMENT AND COL-
- 7 LECTION OF RAILROAD SAFETY DATA.
- 8 (a) In General.—The Administrator of the Federal
- 9 Railroad Administration shall develop a plan, and a
- 10 timeline to carry out such plan, to implement the rec-
- 11 ommendations from the Inspector General Report No.
- 12 ST2017045 of the Department of Transportation, issued
- 13 on May 3, 2017, to the greatest extent possible, to improve
- 14 the Federal Railroad Administration's management and
- 15 collection of railroad safety data.
- 16 (b) Implementation.—
- 17 (1) In general.—Not later than 180 days
- 18 after date of enactment of this Act, the Adminis-
- trator shall submit the plan and timeline developed
- under subsection (a) to the Committee on Transpor-
- 21 tation and Infrastructure of the House of Represent-
- atives and the Committee on Commerce, Science,
- and Transportation of the Senate.

- 1 (2) Report.—The Administrator shall report
- 2 annually to the committees on the implementation of
- 3 such plan until implementation is complete.
- 4 SEC. 3. NO ADDITIONAL FUNDS AUTHORIZED.
- 5 No additional funds are authorized to carry out the
- 6 requirements of this Act. Such requirements shall be car-
- 7 ried out using amounts otherwise authorized.
