## Public Health - Certificates of Birth - Births Outside an Institution

3 FOR the purpose of requiring the attending clinician or a designee of the attending clinician 4 to prepare a certificate of birth, secure certain signatures, and file the certificate 5 within a certain time period after a birth occurs outside an institution with an 6 attending clinician; requiring the attending clinician, within a certain time period 7 after the birth, to provide certain information that is required on a certificate of birth; 8 requiring the attending clinician or a designee of the attending clinician to take 9 certain actions on the birth of a child to an unmarried woman outside an institution 10 with an attending clinician; providing that the attending clinician or a designee of 11 the attending clinician may not be held liable in any cause of action arising out of 12 the establishment of paternity; defining certain terms; making a conforming change; 13 making a stylistic change; making this Act an emergency measure; and generally 14 relating to certificates of birth for births outside an institution.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 2 That the Laws of Maryland read as follows:

## 3 Article – Health – General

- 5 (a) In this subtitle the following words have the meanings indicated.
- 6 (B) "ATTENDING CLINICIAN" MEANS THE PHYSICIAN, NURSE MIDWIFE, OR 7 DIRECT-ENTRY MIDWIFE IN CHARGE OF A BIRTH OUTSIDE AN INSTITUTION.
- 8 **[(b)] (C)** "Attending physician" means the physician in charge of the patient's care for the illness or condition which resulted in death.
- 10 **[(c)] (D)** "County registrar" means the registrar of vital records for a county.
- 11 **[**(d)**] (E)** (1) "Dead body" means:
- 12 (i) A dead human body; or
- 13 (ii) Parts or bones of a human body if, from their condition, an 14 individual reasonably may conclude that death has occurred.
- 15 (2) "Dead body" does not include an amputated part.
- 16 (F) "DIRECT-ENTRY MIDWIFE" MEANS AN INDIVIDUAL LICENSED TO 17 PRACTICE DIRECT-ENTRY MIDWIFERY UNDER TITLE 8, SUBTITLE 6C OF THE 18 HEALTH OCCUPATIONS ARTICLE.
- [(e)] (G) "Fetal death" means death of a product of human conception, before its complete expulsion or extraction from the mother, regardless of the duration of the pregnancy, as indicated by the fact that, after the expulsion or extraction, the fetus does not breathe or show any other evidence of life, such as heart beat, pulsation of the umbilical cord, or definite movement of voluntary muscle.
- [(f)] (H) "File" means to present for registration any certificate, report, or other record including records transmitted by approved electronic media, including facsimile, of birth, death, fetal death, adoption, marriage, or divorce for which this subtitle provides and to have the Secretary accept the record.
- [(g)] (I) "Filing date" means the date a vital record is accepted for registration by the Secretary.

- 1 (O) "NURSE MIDWIFE" MEANS AN INDIVIDUAL CERTIFIED TO PRACTICE AS 2 A NURSE MIDWIFE UNDER TITLE 8 OF THE HEALTH OCCUPATIONS ARTICLE.
- 3 **[(m)] (P)** "Physician" means a person authorized or licensed to practice medicine 4 or osteopathy pursuant to the laws of this State.
- 5 **[(n)] (Q)** "Physician assistant" means an individual who is licensed under Title 15 of the Health Occupations Article to practice medicine with physician supervision.
- [(o)] (R) "Registration" means acceptance by the Secretary and incorporation in the records of the Department of any certificate, report, or other record of birth, death, fetal death, adoption, marriage, divorce, or dissolution or annulment of marriage for which this subtitle provides.
- [(p)] (S) "Vital record" means a certificate or report of birth, death, fetal death, marriage, divorce, dissolution or annulment of marriage, adoption, or adjudication of paternity that is required by law to be filed with the Secretary.
- [(q)] (T) "Vital statistics" means the data derived from certificates and reports of birth, death, fetal death, marriage, divorce, dissolution or annulment of marriage, and reports related to any of these certificates and reports.

- 18 (a) (1) Within 5 calendar days after a birth occurs in an institution, or en route 19 to the institution, **OR OUTSIDE AN INSTITUTION WITH AN ATTENDING CLINICIAN**, the 20 administrative head of the institution or a designee of the administrative head, **OR THE** 21 **ATTENDING CLINICIAN OR A DESIGNEE OF THE ATTENDING CLINICIAN**, shall:
- 22 (i) Prepare, on the form that the Secretary provides, a certificate of 23 birth;
- 24 (ii) Secure each signature that is required on the certificate; and
- 25 (iii) File the certificate.
- 26 (2) The attending physician, physician assistant, nurse practitioner, [or]
  27 nurse midwife, **OR ATTENDING CLINICIAN** shall provide the date of birth and medical
  28 information that are required on the certificate within 5 calendar days after the birth.
- 29 (3) The results of the universal hearing screening of newborns shall be 30 incorporated into the supplemental information required by the Department to be 31 submitted as a part of the birth event.
- 32 (4) [Upon] **ON** the birth of a child to an unmarried woman in an institution 33 **OR OUTSIDE AN INSTITUTION WITH AN ATTENDING CLINICIAN**, the administrative

- head of the institution or the designee of the administrative head, OR THE ATTENDING
   CLINICIAN OR THE DESIGNEE OF THE ATTENDING CLINICIAN, shall:
- 3 (i) Provide an opportunity for the child's mother and the father to complete a standardized affidavit of parentage recognizing parentage of the child on the standardized form provided by the Department of Human Resources under § 5–1028 of the Family Law Article;
- 7 (ii) Furnish to the mother written information prepared by the Child 8 Support Enforcement Administration concerning the benefits of having the paternity of her 9 child established, including the availability of child support enforcement services; and
- 10 (iii) Forward the completed affidavit to the Department of Health 11 and Mental Hygiene, Division of Vital Records. The Department of Health and Mental 12 Hygiene, Division of Vital Records shall make the affidavits available to the parents, 13 guardian of the child, or a child support enforcement agency upon request.
- 14 (5) An institution, the administrative head of the institution, the designee 15 of the administrative head of an institution, [and] an employee of an institution, THE 16 ATTENDING CLINICIAN, AND THE DESIGNEE OF THE ATTENDING CLINICIAN may not 17 be held liable in any cause of action arising out of the establishment of paternity.
- 18 (6) If the child's mother was not married at the time of either conception or 19 birth or between conception and birth, the name of the father may not be entered on the 20 certificate without an affidavit of paternity as authorized by § 5–1028 of the Family Law 21 Article signed by the mother and the person to be named on the certificate as the father.
- 22 (7) In any case in which paternity of a child is determined by a court of competent jurisdiction, the name of the father and surname of the child shall be entered on the certificate of birth in accordance with the finding and order of the court.
- 25 (8) If the father is not named on the certificate of birth, no other 26 information about the father shall be entered on the certificate.
- 27 (b) Within 5 calendar days after a birth occurs outside an institution WITHOUT 28 AN ATTENDING CLINICIAN, the birth shall be verified by the Secretary and a certificate 29 of birth shall be prepared, on the form that the Secretary provides, and filed by one of the 30 following, in the indicated order of priority:
- 31 (1) The attending individual.
- 32 (2) In the absence of an attending individual, the father or mother.
- 33 (3) In the absence of the father and the inability of the mother, the individual in charge of the premises where the birth occurred.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
