2 **Grant Applications and Reporting – Uniform Forms and Requirements**

3 FOR the purpose of establishing the Maryland Efficient Grant Application Council;
4 providing for the composition, chair, and staffing of the Council; establishing the
5 terms of certain members of the Council; prohibiting a member of the Council from
6 receiving certain compensation, but authorizing the reimbursement of certain
7 expenses; requiring the Council to advise the Governor's Grants Office and the ~~Board~~
8 ~~of Public Works~~ Department of Budget and Management regarding certain matters;
9 requiring the Council to monitor and report on certain matters; requiring the Council
10 to study and make recommendations to the Governor's Grants Office and the ~~Board~~
11 Department regarding the grants life cycle, including the creation of certain
12 materials for use by certain grant-making agencies, grant applicants, and grant
13 recipients, certain regulations, and certain recommended timelines and deadlines;

(E) THE STAFFING RESPONSIBILITIES OF THE COUNCIL SHALL BE SHARED BY THE AGENCIES REPRESENTED ON THE COUNCIL.

(F) A MEMBER OF THE COUNCIL:

(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE COUNCIL; BUT

(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

SECTION ~~4~~ 3. AND BE IT FURTHER ENACTED, That the terms of the initial members appointed to the Maryland Efficient Grant Application Council by the Governor shall expire as follows:

(1) two members in 2022; and

(2) ~~two~~ three members in 2024.

SECTION ~~5~~ 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020. It shall remain effective for a period of 5 years and, at the end of June 30, 2025, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
