Ms. Kamlager-Dove (for herself, Ms. Salazar, and Mr. Castro of Texas) introduced the following bill; which was referred to the Committee on Foreign Affairs

A BILL

To direct the Secretary of State to host regular Summits of the Americas, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Summit of the Amer-
- 5 icas Act".
- 6 SEC. 2. SUMMIT OF THE AMERICAS AND RELATED MAT-
- 7 TERS.
- 8 (a) STATEMENT OF POLICY.—It shall be the policy
- 9 of the United States to work with the Summit of the
- 10 Americas Secretariat to support the organization of a

- Summit of the Americas every four years, or more frequently as appropriate, subject to the availability of funds, to strengthen ties and promote cooperation between the 4 United States and countries in the Western Hemisphere, 5 as well as civil society, business, diaspora, women, and 6 youth leaders. 7 (b) AUTHORIZATION.—The Secretary of State is au-8 thorized to carry out the policy described in subsection (a). 9 (c) CITIES SUMMIT OF THE AMERICAS.— (1) FINDINGS.—Congress finds the following: 10 11 Subnational diplomacy strengthens (A)12 democratic governance by enhancing local lead-13 ers' ability to tackle shared challenges, and 14 deepens United States ties with regional part-15 ners by localizing bilateral and multilateral 16 partnerships and connections. 17 (B) The first-ever Cities Summit of the 18 Americas in 2023 promoted a valuable ex-19 change of best practices and lessons learned be-20 tween city, State, municipal, and regional lead-21 ers and should be held as part of the Summit 22 of the Americas process. 23 (2) IN GENERAL.—The Secretary of State is
 - (2) IN GENERAL.—The Secretary of State is authorized to work with the Summit of the Americas Secretariat to support the organization of one Cities

1	Summit of the Americas, across cities in the West-
2	ern Hemisphere, including the United States, to
3	take place as a part of each Summit of the Americas
4	described in subsection (a), to promote subnational
5	cooperation and serve as a catalyst in fostering en-
6	gagement with representatives of government, civil
7	society, business, academia, youth, culture and the
8	arts, Latin American and Caribbean diaspora com-
9	munities, and underrepresented groups.
10	(d) Summit of the Americas Implementation
11	Unit.—
12	(1) In General.—The Secretary of State is
13	authorized to establish within the Department of
14	State a Summit of the Americas implementation
15	unit responsible for overseeing the implementation of
16	commitments made at summits described in this sec-
17	tion.
18	(2) Duties.—The duties of the implementation
19	unit authorized by this subsection include—
20	(A) tracking and ensuring implementation
21	of commitments made during Summits of the
22	Americas;
23	(B) liaising with interagency partners and
24	the National Security Council regarding imple-
25	mentation of summit commitments; and

1	(C) reporting quarterly on a public website
2	of the Department of State regarding progress
3	to accomplish summit commitments and status
4	of commitments across Federal departments
5	and agencies.
6	(e) Report.—The Secretary of State shall submit to
7	the Committee on Foreign Affairs of the House of Rep-
8	resentatives and the Committee on Foreign Relations of
9	the Senate annually for 5 years beginning after the date
10	of the enactment of this Act a report on the implementa-
11	tion of this section, including the status of commitments
12	of the United States and participating partners for the
13	prior year and upcoming year.
