# H. R. 2446

To award three Congressional Gold Medals to the law enforcement officers and those who protected American cities during the Black Lives Matter (BLM) riots beginning on May 26, 2020.

### IN THE HOUSE OF REPRESENTATIVES

Mrs. Greene of Georgia introduced the following bill; which was referred to the Committee on Financial Services, and in addition to the Committee on House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

# A BILL

To award three Congressional Gold Medals to the law enforcement officers and those who protected American cities during the Black Lives Matter (BLM) riots beginning on May 26, 2020.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. FINDINGS.
- 4 The Congress finds the following:
- 5 (1) Every day, police officers around the United
- 6 States put their lives in danger in order to protect
- 7 the American public.

- 1 (2) On May 26, 2020, violent riots broke out in 2 Minneapolis, Minnesota, sparking copycat riots in 3 cities across the country.
  - (3) The sacrifice and courage of heroes including more than 2,000 law enforcement officers who sustained injuries exemplify the patriotism and the commitment of police officers, and those of other law enforcement agencies, to risk their lives in service of our country.
    - (4) At least 25 Americans died following the violent riots, and more than 2,000 law enforcement officers suffered physical injuries.
- 13 (5) The desecration of American cities including 14 the destruction of over 700 buildings in Minneapolis 15 alone, over 2,385 incidents of looting, the arrest of 16 16,200 for riot-related crimes, and the millions of 17 dollars of damage done are horrors that will forever 18 stain our Nation's history.

## 19 SEC. 2. CONGRESSIONAL GOLD MEDALS.

20 (a) Presentation Authorization.—The Speaker 21 of the House of Representatives and the President pro 22 tempore of the Senate shall make appropriate arrange-23 ments for the presentation, on behalf of the Congress, of 24 three gold medals of appropriate design to the Minneapolis 25 Police Department, the Portland Police Department, and

3	(b) DESIGN AND STRIKING.—For the purposes of the
4	award referred to in subsection (a), the Secretary of the
5	Treasury (hereafter in this Act referred to as the "Sec
6	retary") shall strike gold medals with suitable emblems
7	devices, and inscriptions, to be determined by the Sec
8	retary.
9	(c) Disposition of Medals.—Following the award
10	of the gold medals under subsection (a):
11	(1) Minneapolis police department head
12	QUARTERS.—One gold medal shall be given to the
13	Minneapolis Police Department, so that the meda
14	may be displayed at the headquarters of the Min
15	neapolis Police Department and made available for
16	display.
17	(2) PORTLAND POLICE DEPARTMENT HEAD
18	QUARTERS.—One gold medal shall be given to the
19	Portland Police Department, so that the medal may
20	be displayed at the headquarters of the Portland Po
21	lice Department and made available for display.
22	(3) Smithsonian institution.—
23	(A) IN GENERAL.—One gold medal shal
24	be given to the Smithsonian Institution, where

- 1 it shall be available for display as appropriate 2 and available for research.
  - (B) PLAQUE.—In displaying the gold medal given under subparagraph (A), the Smithsonian Institution shall display the medal with a plaque that lists the other law enforcement agencies that participated in protecting the American people during the BLM riots beginning on May 26th.
    - (C) Sense of the Congress.—It is the sense of the Congress that the Smithsonian Institution should make the gold medal given under subparagraph (A) available for display elsewhere, particularly at appropriate locations associated with the protection of American cities during the BLM riots beginning on May 26th.

#### 18 SEC. 3. DUPLICATE MEDALS.

The Secretary may strike and sell duplicates in 20 bronze of the gold medals struck pursuant to section 2 21 under such regulations as the Secretary may prescribe, at 22 a price sufficient to cover the cost thereof, including labor, 23 materials, dies, use of machinery, and overhead expenses.

#### 1 SEC. 4. SENSE OF CONGRESS.

- 2 It is the sense of the Congress that the United States
- 3 Mint should expedite production of the gold medals and
- 4 duplicate medals under this Act, so that the sacrifices of
- 5 fallen officers and their families, and the contributions of
- 6 other law enforcement agencies who answered the call of
- 7 duty during the BLM riots beginning on May 26th can
- 8 be recognized and honored in a timely manner.

#### 9 SEC. 5. STATUS OF MEDALS.

- 10 (a) National Medals.—The medals struck pursu-
- 11 ant to this Act are national medals for purposes of chapter
- 12 51 of title 31, United States Code.
- 13 (b) Numismatic Items.—For purposes of section
- 14 5134 of title 31, United States Code, all medals struck
- 15 under this Act shall be considered to be numismatic items.

#### 16 SEC. 6. FINANCIAL ASSURANCES.

- 17 The Secretary of the Treasury shall take such actions
- 18 as may be necessary to ensure that the minting and
- 19 issuing of coins under this Act will not result in any net
- 20 cost to the United States Government.
