1	A JOINT RESOLUTION directing mental health professional licensure boards to
2	strongly consider entering into an interstate compact with other states, easing reciprocity
3	procedures with other states, or establishing reciprocity procedures with other states to

5	WHEREAS, approximately 746,000 adults in Kentucky have a mental health
6	condition and about 113,069 individuals have a severe mental illness; and
7	WHEREAS, there is a mental health workforce shortage in Kentucky; and
8	WHEREAS, mental health providers are more likely to practice in urban centers
9	and this causes chronic shortages of mental health professionals in rural areas of
10	Kentucky; and
11	WHEREAS, there are only 350 actively practicing psychiatrists in Kentucky, about
12	eight per 100,000 residents, and to adequately serve individuals with mental health issues
13	there should be at least 50 actively practicing psychiatrists per 100,000 residents; and
14	WHEREAS, due to a chronic shortage of psychiatrists, primary care providers are
15	providing up to 74 percent of all psychiatric care in the United States and primary care
16	providers may not have the training or experience to accurately diagnose or treat
17	individuals with severe mental illness or other mental health conditions; and
18	WHEREAS, Community Mental Health Centers (CMHCs) and Certified
19	Community Behavioral Health Clinics (CCBHCs) provide comprehensive mental health
20	and substance use disorder services to vulnerable individuals and, to provide these
21	services, the CMHCs and CCBHCs must have enough qualified mental health providers
22	to meet the needs of communities;
23	NOW, THEREFORE,
24	Be it resolved by the General Assembly of the Commonwealth of Kentucky:
25	→ Section 1. The General Assembly hereby directs the following boards to
26	strongly consider entering into an interstate compact with other states, easing reciprocity

- workforce in Kentucky, an emergency is declared to exist, and this Resolution takes effect
- upon its passage and approval by the Governor or upon its otherwise becoming law.
