12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Natural Resources**

15 **5–1011.1.**

16 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
17 INDICATED.

18 (2) “BOARD” MEANS THE OFF-HIGHWAY RECREATIONAL VEHICLE
19 RECREATION OVERSIGHT BOARD.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

1 **(3) “FUND” MEANS THE OFF-HIGHWAY RECREATIONAL VEHICLE**
2 **TRAIL FUND ESTABLISHED UNDER § 5-1011 OF THIS SUBTITLE.**

3 **(B) THERE IS AN OFF-HIGHWAY RECREATIONAL VEHICLE RECREATION**
4 **OVERSIGHT BOARD.**

5 **(C) (1) THE BOARD CONSISTS OF THE FOLLOWING MEMBERS,**
6 **APPOINTED BY THE GOVERNOR:**

7 **(I) ONE REPRESENTATIVE OF THE MARYLAND OFF-HIGHWAY**
8 **VEHICLE ALLIANCE;**

9 **(II) ONE REPRESENTATIVE OF THE MARYLAND MOTORCYCLE**
10 **DEALERS ASSOCIATION;**

11 **(III) ONE REPRESENTATIVE OF THE AMERICAN MOTORCYCLIST**
12 **ASSOCIATION DISTRICT 7;**

13 **(IV) ONE INDIVIDUAL REPRESENTING ALL-TERRAIN VEHICLE,**
14 **UTILITY TERRAIN VEHICLE, OR SIDE-BY-SIDE VEHICLE DRIVERS; AND**

15 **(V) ONE INDIVIDUAL REPRESENTING ON- AND OFF-ROAD**
16 **MOTOR VEHICLE DRIVERS.**

17 **(2) EACH MEMBER SHALL BE A RESIDENT OF THE STATE.**

18 **(D) FROM AMONG ITS MEMBERS, THE BOARD SHALL ELECT A CHAIR EACH**
19 **YEAR.**

20 **(E) (1) THE TERM OF A MEMBER IS 4 YEARS.**

21 **(2) THE TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY THE**
22 **TERMS PROVIDED FOR MEMBERS OF THE BOARD ON OCTOBER 1, 2025.**

23 **(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL**
24 **A SUCCESSOR IS APPOINTED AND QUALIFIES.**

25 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
26 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
27 **QUALIFIES.**

(5) IF A VACANCY OCCURS AMONG THE MEMBERS, THE GOVERNOR SHALL PROMPTLY APPOINT A SUCCESSOR WHO SHALL SERVE UNTIL THE TERM EXPIRES.

(F) (1) THE DEPARTMENT SHALL PROVIDE STAFF FOR THE BOARD.

(2) ADDITIONAL SUPPORT FOR THE BOARD SHALL BE PROVIDED BY:

(I) THE SECRETARY, OR THE SECRETARY'S DESIGNEE;

(II) THE MARYLAND PARK SERVICE;

(III) THE FOREST SERVICE;

(IV) THE WILDLIFE AND HERITAGE SERVICE; AND

(V) ONE REPRESENTATIVE OF EACH COUNTY IN WHICH AN OFF-HIGHWAY RECREATIONAL VEHICLE TRAIL MAINTAINED BY THE DEPARTMENT IS LOCATED, DESIGNATED BY THE DEPARTMENT.

(G) THE BOARD SHALL MEET AT LEAST QUARTERLY.

(H) THE BOARD SHALL:

~~(1) ADVISE~~ ADVISE THE SECRETARY ON THE OPERATION, ACQUISITION, REGULATION, AND GENERAL OVERSIGHT OF OFF-HIGHWAY RECREATIONAL VEHICLE TRAILS AND RECREATION IN THE STATE; ~~AND~~

~~(2) REVIEW EXPENDITURES FROM THE FUND IN ACCORDANCE WITH SUBSECTION (I) OF THIS SECTION.~~

~~(I) AN EXPENDITURE FROM THE FUND SHALL BE REVIEWED BY THE BOARD IN ACCORDANCE WITH THE FOLLOWING RECOMMENDATIONS:~~

~~(1) AT LEAST 25% OF THE ANNUAL FUND BALANCE SHALL BE USED FOR TRAIL DEVELOPMENT;~~

~~(2) AT LEAST 10% OF THE ANNUAL FUND BALANCE SHALL BE USED FOR OFF-HIGHWAY RECREATIONAL VEHICLE TRAIL MAINTENANCE;~~

~~(3) AT LEAST 10% OF THE ANNUAL FUND BALANCE SHALL BE USED FOR THE DEVELOPMENT OR MAINTENANCE OF CAMPING SITES, PARKING, OR OTHER INFRASTRUCTURE NECESSARY TO SUPPORT OFF-HIGHWAY RECREATIONAL~~

~~VEHICLE RIDERS AND RECREATIONAL ACTIVITIES ON LANDS MANAGED PRIMARILY
FOR OFF-HIGHWAY RECREATIONAL VEHICLE USE;~~

~~(4) AT LEAST 5% OF THE ANNUAL FUND BALANCE SHALL BE USED TO
LEASE LANDS FOR PUBLIC OFF-HIGHWAY RECREATIONAL VEHICLE USE;~~

~~(5) AT LEAST 10% OF THE ANNUAL FUND BALANCE SHALL BE
AUTHORIZED TO ADVERTISE, PROMOTE, AND MARKET OFF-HIGHWAY
RECREATIONAL VEHICLE USE AND EDUCATION IN THE STATE; AND~~

~~(6) FUNDS FROM THE FUND SHALL BE USED TO COVER THE
ADMINISTRATIVE AND OPERATING COSTS OF THE BOARD.~~

SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial
appointed members of the Off-Highway Recreational Vehicle Recreation Oversight Board
established under Section 1 of this Act shall expire as follows:

- (1) one member in 2026;
- (2) two members in 2027; and
- (3) two members in 2028.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
October 1, 2025.
