- FOR the purpose of requiring certain carriers that issue, deliver, or offer policies, contracts, or certificates of long—term care insurance in the State and sell or otherwise transfer their books of business to another carrier to, at least a certain number of days before the sale or transfer, provide certain written notice to each insured and provide a certain database to the Maryland Insurance Commissioner; making this Act an emergency measure; and generally relating to long—term care insurance.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
