## A BILL ENTITLED

1 AN ACT concerning

2 **Long-Term Care Insurance – Sale or Transfer of Book of Business**

3 FOR the purpose of requiring certain carriers that issue, deliver, or offer policies, contracts,  
4 or certificates of long-term care insurance in the State and sell or otherwise transfer  
5 their books of business to another carrier to, at least a certain number of days before  
6 the sale or transfer, provide certain written notice to each insured and provide a  
7 certain database to the Maryland Insurance Commissioner; making this Act an  
8 emergency measure; and generally relating to long-term care insurance.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – Insurance**

17 **18–118.1.**

18 **IF A CARRIER THAT ISSUES, DELIVERS, OR OFFERS A POLICY, CONTRACT, OR**  
19 **CERTIFICATE OF LONG-TERM CARE INSURANCE IN THE STATE SELLS OR**  
20 **OTHERWISE TRANSFERS ITS BOOK OF BUSINESS TO ANOTHER CARRIER, THE**  
21 **CARRIER, AT LEAST 14 DAYS BEFORE THE SALE OR TRANSFER, SHALL PROVIDE:**

22 **(1) TO EACH INSURED WRITTEN NOTICE THAT:**

1                   **(I)    ADVISES THE INSURED THAT THE CARRIER’S BOOK OF**  
2 **BUSINESS IS BEING SOLD OR OTHERWISE TRANSFERRED TO ANOTHER CARRIER;**  
3 **AND**

4                   **(II)   INCLUDES THE CONTACT INFORMATION OF THE CARRIER**  
5 **TO WHICH THE BOOK OF BUSINESS IS BEING SOLD OR OTHERWISE TRANSFERRED;**  
6 **AND**

7                   **(2)    TO THE COMMISSIONER A DATABASE THAT INCLUDES THE NAME,**  
8 **ADDRESS, AND POLICY NUMBER OF EACH INSURED WHOSE POLICY, CONTRACT, OR**  
9 **CERTIFICATE IS BEING SOLD OR OTHERWISE TRANSFERRED TO ANOTHER CARRIER.**

10           SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency  
11 measure, is necessary for the immediate preservation of the public health or safety, has  
12 been passed by a yea and nay vote supported by three–fifths of all the members elected to  
13 each of the two Houses of the General Assembly, and shall take effect from the date it is  
14 enacted.
