Mr. GALLAGHER (for himself, Mr. KIM of New Jersey, Mrs. McCLAIN, and Mrs. MURPHY of Florida) introduced the following bill; which was referred to the Committee on Foreign Affairs, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To require an annual report on cooperation between the National Guard and Taiwan, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Taiwan Partnership
5 Act”.

6 **SEC. 2. SENSE OF CONGRESS.**

7 It is the sense of Congress that the United States
8 should—

1 (1) continue to support the development of ca-
2 pable, ready, and modern defense forces necessary
3 for Taiwan to maintain a sufficient self-defense ca-
4 pability by increasing exchanges between senior de-
5 fense officials and general officers of the United
6 States and Taiwan at the strategic, policy, and func-
7 tional levels, consistent with the Taiwan Travel Act
8 (Public Law 115–135; 132 Stat. 341), especially for
9 the purposes of—

10 (A) improving the interoperability of the
11 military forces of the United States and Tai-
12 wan;

13 (B) improving the reserve force of Taiwan;

14 (C) expanding cooperation in humanitarian
15 assistance and disaster relief; and

16 (D) expanding military to military medical
17 cooperation;

18 (2) expand and strengthen Taiwan’s capability
19 to conduct security activities, including traditional
20 activities of the combatant commands, cooperation
21 with the National Guard, and through multilateral
22 activities; and

23 (3) using appropriate authorities and consistent
24 with the Taiwan Relations Act (Public Law 96–8;
25 22 U.S.C. 3301 et seq.), seek to develop a partner-

1 ship between the National Guard and Taiwan as a
2 means of maintaining a sufficient self-defense capa-
3 bility.

4 **SEC. 3. ANNUAL REPORT ON COOPERATION BETWEEN THE**
5 **NATIONAL GUARD AND TAIWAN.**

6 (a) IN GENERAL.—Not later than February 15,
7 2022, and annually thereafter, the Secretary of Defense
8 shall submit to the congressional defense committees (as
9 defined in section 101 of title 10, United States Code)
10 a report on the feasibility and advisability of enhanced co-
11 operation between the National Guard and Taiwan.

12 (b) ELEMENTS.—Each report required by subsection
13 (a) shall include the following:

14 (1) A description of the cooperation between the
15 National Guard and Taiwan during the preceding
16 calendar year, including mutual visits, exercises,
17 training, and equipment opportunities.

18 (2) An evaluation of the feasibility of enhancing
19 cooperation between the National Guard and Taiwan
20 on a range of activities, including—

21 (A) disaster and emergency response;

22 (B) cyber defense and communications se-
23 curity;

24 (C) military medical cooperation;

1 (D) cultural exchange and education of
2 members of the National Guard in Mandarin
3 Chinese; and

4 (E) programs for National Guard advisors
5 to assist in training the reserve components of
6 the military forces of Taiwan.

7 (3) Recommendations to enhance such coopera-
8 tion and improve interoperability, including through
9 familiarization visits, cooperative training and exer-
10 cises, and co-deployments.

11 (4) Any other matter the Secretary of Defense
12 determines appropriate.
