"(a1) Fees. – All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

SECTION 4. G.S. 20-79.7(b) reads as rewritten:

Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a1) of this section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the North Carolina Land and Water Fund (NCLWF), which is established under G.S. 143B-135.234, and the Parks and Recreation Trust Fund, which is established under G.S. 143B-135.56, as follows:

SECTION 5. G.S. 20-81.12 is amended by adding a new subsection to read:

"() Birthplace of American Independence. – The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of "Birthplace of American Independence" plates to Halifax County Business Horizons, Inc., to support commemorative and educational activities in conjunction with the 250th anniversary of the signing of the Halifax Resolves."

SECTION 6. The Revisor of Statutes is authorized to alphabetize, number, and renumber the special registration plates listed in G.S. 20-63(b1), 20-79.4(b), 20-79.7(a1) and (b), and 20-81.12 to ensure that all the special registration plates are listed in alphabetical order and numbered accordingly.

SECTION 7. This act is effective when it becomes law.
