# A BILL

To require the Secretary of Commerce to establish a grant program to benefit coastal habitats, resiliency, and the economy, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Shovel-Ready Restora-
- 5 tion Grants for Coastlines and Fisheries Act of 2020".

## 1 SEC. 2. GRANT PROGRAM FOR COASTAL RESILIENCY.

2	(a) Establishment.—The Secretary shall establish
3	a grant program to provide funding and technical assist-
4	ance to eligible entities for purposes of carrying out a
5	project described in subsection (d)
6	(b) Project Proposal.—To be considered for a
7	grant under this section, an eligible entity shall submit
8	a grant proposal to the Secretary in a time, place, and
9	manner determined by the Secretary. Such proposal shall
10	include monitoring, data collection, and measurable per-
11	formance criteria with respect to the project.
12	(c) Development of Criteria.—The Secretary
13	shall select eligible entities to receive grants under this
14	section based on criteria developed by the Secretary, in
15	consultation with relevant offices of the National Oceanic
16	and Atmospheric Administration, such as the Office of
17	Habitat Conservation and the Office for Coastal Manage-
18	ment.
19	(d) Eligible Projects.—A project is described by
20	this section if—
21	(1) the purpose of the project is to restore a
22	marine, estuarine, coastal, or Great Lake habitat,
23	including—
24	(A) restoration of habitat to protect or re-

cover a species that is threatened, endangered,

1	or a species of concern under the Endangered
2	Species Act of 1973 (16 U.S.C. 1531 et seq.)
3	(B) through the removal or remediation of
4	marine debris, including derelict vessels and
5	fishing gear, in coastal and marine habitats;
6	(C) for the benefit of—
7	(i) shellfish;
8	(ii) fish, including diadromous fish; or
9	(iii) coral reef; or
10	(2) provides adaptation to climate change, in-
11	cluding by constructing or protecting ecological fea-
12	tures or green infrastructure that protects coasta
13	communities from sea level rise, coastal storms, or
14	flooding, and blue carbon projects.
15	(e) Priority.—In determining which projects to
16	fund under this section, the Secretary shall give priority
17	to a proposed project—
18	(1) that would stimulate the economy;
19	(2) for which the applicant can demonstrate
20	that the grant will fund work that will begin not
21	more than 90 days after the date of the award;
22	(3) for which the applicant can demonstrate
23	that the grant will fund work that will employ fish-
24	ermen who have been negatively impacted by the

- 1 COVID-19 pandemic or pay a fisherman for the use 2 of a fishing vessel;
- (4) for which the applicant can demonstrate
  that any preliminary study or permit required before
  the project can begin has been completed or can be
  completed shortly after an award is made; or
- 7 (5) which include communities that may not 8 have adequate resources including low income com-9 munities, communities of color, Tribal communities, 10 and rural communities.
- 11 (f) AUTHORIZATION OF APPROPRIATIONS.—There is 12 authorized to be appropriated \$3,000,000,000 for fiscal 13 year 2020 to the Secretary of Commerce to carry out this 14 section to remain available until expended.

### 15 (g) Definitions.—

- 16 (1) ELIGIBLE ENTITY.—In this Act, "eligible 17 entity" means a nonprofit, a for-profit business, an 18 institution of higher education (as such term is de-19 fined in section 101(a) of the Higher Education Act 20 of 1965 (20 U.S.C. 1001(a))), or a State, local, 21 Tribal, or territorial government.
- 22 (2) FISHERMEN.—The term "fisherman"
  23 means a commercial or for-hire fisherman or an oys24 ter farmer.

1 (3) SECRETARY.—In this section, the term 2 "Secretary" means the Secretary of Commerce, act-3 ing through the the Administrator of the National 4 Oceanic and Atmospheric Administration.
