BY repealing and reenacting, with amendments, Article – Tax – General Section 10-745 Annotated Code of Maryland (2022 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Tax - General 10 - 745.

- 1 (a) (1) In this section the following words have the meanings indicated. 2 "Certified organic produce" means an eligible food donation that is (2) 3 certified under Title 10, Subtitle 14 of the Agriculture Article as an organically produced commodity. 4 5 "Eligible food donation" means fresh farm products for human (3) 6 consumption. 7 "Qualified farm" means a farm business that is located in the State. (4) "Secretary" means the Secretary of Agriculture or the Secretary's 8 (5)9 designee. 10 "Tax credit certificate administrator" (6)means a person or an organization that is authorized by the State Department of Agriculture under subsection 11 12 (e) of this section to receive eligible food donations. 13 Subject to the limitations of this section, for a taxable year beginning (b) 14 after December 31, 2016, but before January 1, [2024] 2026, a qualified farm may claim a credit against the State income tax in the amount stated on any tax credit certificates 15 16 issued to the qualified farm during the taxable year. 17 (2)Except as provided in subparagraph (ii) of this paragraph, for (i) 18 any taxable year, the aggregate amount of credits authorized under this subsection for a 19 qualified farm may not exceed \$5,000. 20 (ii) For any taxable year, the Secretary may increase the credit 21limitation under subparagraph (i) of this paragraph for a qualified farm by an amount not 22 to exceed \$5,000. 23 If the credit allowed under this section exceeds the State income tax, 24any unused credit may be carried forward and applied for succeeding taxable years until 25the earlier of: 26 (i) the date on which the full amount of the credit is used; or 27 the date of the expiration of the 5th year after the taxable year 28 for which the credit was allowed. 29 A qualified farm that makes an eligible food donation is eligible for a (c)

- Each week the Secretary shall establish and publish the categories and 1 (d) (1) 2 value of certified organic produce and eligible food donations. 3 **(2)** Except as provided in paragraph (3) of this subsection, the value of each category of certified organic produce and eligible food donations is the wholesale value of 4 the category established by the State Department of Agriculture and based on United 5 6 States Department of Agriculture reports on Maryland products sold at Maryland markets. 7 If the Secretary determines that the value established under paragraph 8 (2) of this subsection is insufficient to pay for the cost of harvesting a category of certified 9 organic produce or eligible food donation, the Secretary may establish a value in excess of the value under paragraph (2) of this subsection. 10 11 The Secretary, in consultation with the Comptroller, shall establish a (e) (1)12 process to certify a person or an organization to act as a tax credit certificate administrator. 13 (2)A tax credit certificate administrator that receives a donation of 14 certified organic produce or an eligible food donation from a qualified farm shall issue the qualified farm a tax credit certificate. 15 16 (3)The tax credit certificate shall: 17 (i) state the date of the donation; 18 identify the qualified farm; (ii) 19 (iii) describe the type of donation; 20 state the weight of the donation; (iv) 21 identify the value of the donation; (v) 22 state the maximum amount of the tax credit for which the (vi) 23 qualified farm is eligible; and 24provide any other information the State Department of Agriculture or Comptroller requires. 25
- 28 (5) Within 30 days after issuing a tax credit certificate, the tax credit 29 certificate administrator shall provide a copy of the tax credit certificate to the Secretary 30 and the Comptroller.

- 1 (6) (i) The Secretary shall notify each tax credit certificate 2 administrator to stop issuing tax credit certificates if the amount of tax credit certificates 3 issued during the fiscal year equals or exceeds the amount of tax credit certificates 4 authorized to be issued during the fiscal year under subsection (f) of this section less 5 \$50,000.
- 6 (ii) The Secretary, in consultation with the Comptroller, shall adopt 7 regulations providing procedures to issue the remaining \$50,000 of tax credit certificates 8 under this paragraph.
- 9 (f) (1) For each fiscal year, the total amount of tax credit certificates issued 10 under this section may not exceed \$100,000.
- 11 (2) If the total amount of tax credit certificates issued during any fiscal 12 year totals less than the maximum amount provided under paragraph (1) of this subsection, 13 any excess amount may be carried forward and issued under tax credit certificates in a 14 subsequent fiscal year.
- 15 (3) A tax credit certificate may not be issued after December 31, [2023] 16 2025.
 - (g) On or before January 1, 2018, and January 1 each year thereafter until January 1, [2025] 2027, the Secretary, in consultation with the Comptroller, shall submit a report to the Governor and, subject to § 2–1257 of the State Government Article, the General Assembly on the use and impact of the tax credit established under this section.
- 21 (h) The Secretary, in consultation with the Comptroller, shall adopt regulations 22 to administer this section.
 - SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that the State Department of Agriculture, in an amount consistent with the amount of funding expended by the Department before the effective date of this Act in administering the tax credit established under § 10–745 of the Tax General Article, shall continue to fund the marketing of the credit program and facilitate the donation of eligible food donations by qualified farms in accordance with § 10–745 of the Tax General Article, as enacted by Section 1 of this Act, through the reimbursement of transportation costs or direct assistance with the transportation of eligible food donations.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023, and shall be applicable to all taxable years beginning after December 31, 2022.
