

1 AN ACT relating to a tax credit for volunteer firefighters.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 141 IS CREATED TO
4 READ AS FOLLOWS:

5 (1) As used in this section:

6 (a) "Active certified volunteer firefighter" means a firefighter who:

7 1. Volunteers for a qualified fire department;

8 2. Is active with a qualified fire department for the entire taxable year for
9 which the credit is claimed; and

10 3. Appears on the list of certified volunteer firefighters provided by the
11 commission pursuant to subsection (4) of this section;

12 (b) "Commission" means the Commission on Fire Protection Personnel
13 Standards and Education; and

14 (c) "Qualified fire department" has the same meaning as in KRS 95A.510.

15 (2) For taxable years beginning on or after January 1, 2020, but before January 1,
16 2024, a refundable credit shall be allowed for active certified volunteer
17 firefighters against the tax imposed by KRS 141.020 in the amount of one
18 thousand dollars (\$1,000), with the ordering of credits as provided in Section 2 of
19 this Act.

20 (3) (a) The purpose of the credit permitted by subsection (2) of this section is to
21 increase the number of certified volunteer firefighters actively volunteering
22 with a qualified fire department in the Commonwealth.

23 (b) In order to evaluate the effectiveness of the credit in achieving the goal
24 stated in this subsection, the department shall report the following
25 information to the Legislative Research Commission on or before December
26 1, 2021, and on or before every December 1 thereafter as long as the credit
27 permitted by subsection (2) of this section is available;

- 1 1. The number of taxpayers who claimed the credit for each taxable
- 2 year;
- 3 2. The total amount of credit claimed for each taxable year;
- 4 3. Based on the mailing address of the return, the total amount of credits
- 5 claimed by county; and
- 6 4. Based on ranges of adjusted gross income of no larger than five
- 7 thousand dollars (\$5,000), the total amount of deductions claimed for
- 8 each adjusted gross income range.
- 9 (4) The commission shall provide to the department an annual list of all certified
- 10 volunteer firefighters on or before January 15, 2021, and on or before every
- 11 January 15 thereafter as long as the credit permitted by subsection (2) of this
- 12 section is available.

13 ➔Section 2. KRS 141.0205 (Effective June 27, 2019) is amended to read as
14 follows:

15 If a taxpayer is entitled to more than one (1) of the tax credits allowed against the tax
16 imposed by KRS 141.020, 141.040, and 141.0401, the priority of application and use of
17 the credits shall be determined as follows:

- 18 (1) The nonrefundable business incentive credits against the tax imposed by KRS
19 141.020 shall be taken in the following order:
 - 20 (a) The limited liability entity tax credit permitted by KRS 141.0401;
 - 21 (b) The economic development credits computed under KRS 141.347, 141.381,
22 141.384, 141.400, 141.401, 141.403, 141.407, 141.415, 154.12-207, and
23 154.12-2088;
 - 24 (c) The qualified farming operation credit permitted by KRS 141.412;
 - 25 (d) The certified rehabilitation credit permitted by KRS 171.397(1)(a);
 - 26 (e) The health insurance credit permitted by KRS 141.062;
 - 27 (f) The tax paid to other states credit permitted by KRS 141.070;

- 1 (g) The credit for hiring the unemployed permitted by KRS 141.065;
- 2 (h) The recycling or composting equipment credit permitted by KRS 141.390;
- 3 (i) The tax credit for cash contributions in investment funds permitted by KRS
- 4 154.20-263 in effect prior to July 15, 2002, and the credit permitted by KRS
- 5 154.20-258;
- 6 (j) The research facilities credit permitted by KRS 141.395;
- 7 (k) The employer High School Equivalency Diploma program incentive credit
- 8 permitted under KRS 151B.402;
- 9 (l) The voluntary environmental remediation credit permitted by KRS 141.418;
- 10 (m) The biodiesel and renewable diesel credit permitted by KRS 141.423;
- 11 (n) The clean coal incentive credit permitted by KRS 141.428;
- 12 (o) The ethanol credit permitted by KRS 141.4242;
- 13 (p) The cellulosic ethanol credit permitted by KRS 141.4244;
- 14 (q) The energy efficiency credits permitted by KRS 141.436;
- 15 (r) The railroad maintenance and improvement credit permitted by KRS 141.385;
- 16 (s) The Endow Kentucky credit permitted by KRS 141.438;
- 17 (t) The New Markets Development Program credit permitted by KRS 141.434;
- 18 (u) The distilled spirits credit permitted by KRS 141.389;
- 19 (v) The angel investor credit permitted by KRS 141.396;
- 20 (w) The film industry credit permitted by KRS 141.383 for applications approved
- 21 on or after April 27, 2018; and
- 22 (x) The inventory credit permitted by KRS 141.408.
- 23 (2) After the application of the nonrefundable credits in subsection (1) of this section,
- 24 the nonrefundable personal tax credits against the tax imposed by KRS 141.020
- 25 shall be taken in the following order:
- 26 (a) The individual credits permitted by KRS 141.020(3);
- 27 (b) The credit permitted by KRS 141.066;

- 1 (c) The tuition credit permitted by KRS 141.069;
- 2 (d) The household and dependent care credit permitted by KRS 141.067; and
- 3 (e) The income gap credit permitted by KRS 141.066.
- 4 (3) After the application of the nonrefundable credits provided for in subsection (2) of
- 5 this section, the refundable credits against the tax imposed by KRS 141.020 shall be
- 6 taken in the following order:
- 7 (a) The individual withholding tax credit permitted by KRS 141.350;
- 8 (b) The individual estimated tax payment credit permitted by KRS 141.305;
- 9 (c) The certified rehabilitation credit permitted by KRS 171.3961 and
- 10 171.397(1)(b);~~and~~
- 11 (d) The film industry tax credit permitted by KRS 141.383 for applications
- 12 approved prior to April 27, 2018; and
- 13 **(e) The active certified firefighter credit permitted by Section 1 of this Act.**
- 14 (4) The nonrefundable credit permitted by KRS 141.0401 shall be applied against the
- 15 tax imposed by KRS 141.040.
- 16 (5) The following nonrefundable credits shall be applied against the sum of the tax
- 17 imposed by KRS 141.040 after subtracting the credit provided for in subsection (4)
- 18 of this section, and the tax imposed by KRS 141.0401 in the following order:
- 19 (a) The economic development credits computed under KRS 141.347, 141.381,
- 20 141.384, 141.400, 141.401, 141.403, 141.407, 141.415, 154.12-207, and
- 21 154.12-2088;
- 22 (b) The qualified farming operation credit permitted by KRS 141.412;
- 23 (c) The certified rehabilitation credit permitted by KRS 171.397(1)(a);
- 24 (d) The health insurance credit permitted by KRS 141.062;
- 25 (e) The unemployment credit permitted by KRS 141.065;
- 26 (f) The recycling or composting equipment credit permitted by KRS 141.390;
- 27 (g) The coal conversion credit permitted by KRS 141.041;

- 1 (h) The enterprise zone credit permitted by KRS 154.45-090, for taxable periods
2 ending prior to January 1, 2008;
- 3 (i) The tax credit for cash contributions to investment funds permitted by KRS
4 154.20-263 in effect prior to July 15, 2002, and the credit permitted by KRS
5 154.20-258;
- 6 (j) The research facilities credit permitted by KRS 141.395;
- 7 (k) The employer High School Equivalency Diploma program incentive credit
8 permitted by KRS 151B.402;
- 9 (l) The voluntary environmental remediation credit permitted by KRS 141.418;
- 10 (m) The biodiesel and renewable diesel credit permitted by KRS 141.423;
- 11 (n) The clean coal incentive credit permitted by KRS 141.428;
- 12 (o) The ethanol credit permitted by KRS 141.4242;

- 18 (t) The railroad expansion credit permitted by KRS 141.386;
- 19 (u) The Endow Kentucky credit permitted by KRS 141.438;
- 20 (v) The New Markets Development Program credit permitted by KRS 141.434;
- 21 (w) The distilled spirits credit permitted by KRS 141.389;
- 22 (x) The film industry credit permitted by KRS 141.383 for applications approved
23 on or after April 27, 2018; and
- 24 (y) The inventory credit permitted by KRS 141.408.
- 25 (6) After the application of the nonrefundable credits in subsection (5) of this section,
26 the refundable credits shall be taken in the following order:
- 27 (a) The corporation estimated tax payment credit permitted by KRS 141.044;

1 (b) The certified rehabilitation credit permitted by KRS 171.3961 and
2 171.397(1)(b); and

3 (c) The film industry tax credit permitted by KRS 141.383 for applications
4 approved prior to April 27, 2018.

5 ➔Section 3. KRS 131.190 (Effective June 27, 2019) is amended to read as
6 follows:

7 (1) No present or former commissioner or employee of the department, present or
8 former member of a county board of assessment appeals, present or former property
9 valuation administrator or employee, present or former secretary or employee of the
10 Finance and Administration Cabinet, former secretary or employee of the Revenue
11 Cabinet, or any other person, shall intentionally and without authorization inspect or
12 divulge any information acquired by him of the affairs of any person, or information
13 regarding the tax schedules, returns, or reports required to be filed with the
14 department or other proper officer, or any information produced by a hearing or
15 investigation, insofar as the information may have to do with the affairs of the
16 person's business.

17 (2) The prohibition established by subsection (1) of this section shall not extend to:

18 (a) Information required in prosecutions for making false reports or returns of
19 property for taxation, or any other infraction of the tax laws;

20 (b) Any matter properly entered upon any assessment record, or in any way made
21 a matter of public record;

22 (c) Furnishing any taxpayer or his properly authorized agent with information
23 respecting his own return;

24 (d) Testimony provided by the commissioner or any employee of the department
25 in any court, or the introduction as evidence of returns or reports filed with the
26 department, in an action for violation of state or federal tax laws or in any
27 action challenging state or federal tax laws;

- 1 (e) Providing an owner of unmined coal, oil or gas reserves, and other mineral or
2 energy resources assessed under KRS 132.820, or owners of surface land
3 under which the unmined minerals lie, factual information about the owner's
4 property derived from third-party returns filed for that owner's property, under
5 the provisions of KRS 132.820, that is used to determine the owner's
6 assessment. This information shall be provided to the owner on a confidential
7 basis, and the owner shall be subject to the penalties provided in KRS
8 131.990(2). The third-party filer shall be given prior notice of any disclosure
9 of information to the owner that was provided by the third-party filer;
- 10 (f) Providing to a third-party purchaser pursuant to an order entered in a
11 foreclosure action filed in a court of competent jurisdiction, factual
12 information related to the owner or lessee of coal, oil, gas reserves, or any
13 other mineral resources assessed under KRS 132.820. The department may
14 promulgate an administrative regulation establishing a fee schedule for the
15 provision of the information described in this paragraph. Any fee imposed
16 shall not exceed the greater of the actual cost of providing the information or
17 ten dollars (\$10);
- 18 (g) Providing information to a licensing agency, the Transportation Cabinet, or
19 the Kentucky Supreme Court under KRS 131.1817;
- 20 (h) Statistics of gasoline and special fuels gallonage reported to the department
21 under KRS 138.210 to 138.448;
- 22 (i) Providing any utility gross receipts license tax return information that is
23 necessary to administer the provisions of KRS 160.613 to 160.617 to
24 applicable school districts on a confidential basis;
- 25 (j) Providing documents, data, or other information to a third party pursuant to an
26 order issued by a court of competent jurisdiction; or
- 27 (k) Providing information to the Legislative Research Commission under:

- 1 1. KRS 139.519 for purposes of the sales and use tax refund on building
- 2 materials used for disaster recovery;
- 3 2. KRS 141.436 for purposes of the energy efficiency products credits;
- 4 3. KRS 141.437 for purposes of the ENERGY STAR home and the
- 5 ENERGY STAR manufactured home credits;
- 6 4. KRS 148.544 for purposes of the film industry incentives;
- 7 5. KRS 154.26-095 for purposes of the Kentucky industrial revitalization
- 8 tax credits and the job assessment fees;
- 9 6. KRS 141.068 for purposes of the Kentucky investment fund;
- 10 7. KRS 141.396 for purposes of the angel investor tax credit;
- 11 8. KRS 141.389 for purposes of the distilled spirits credit;
- 12 9. KRS 141.408 for purposes of the inventory credit;~~and~~
- 13 10. KRS 141.390 for purposes of the recycling and composting credit; and

14 **11. Section 1 of this Act for the purposes of the active certified volunteer**

15 **firefighter credit.**

16 (3) The commissioner shall make available any information for official use only and on

17 a confidential basis to the proper officer, agency, board or commission of this state,

18 any Kentucky county, any Kentucky city, any other state, or the federal government,

19 under reciprocal agreements whereby the department shall receive similar or useful

20 information in return.

21 (4) Access to and inspection of information received from the Internal Revenue Service

22 is for department use only, and is restricted to tax administration purposes.

23 Information received from the Internal Revenue Service shall not be made available

24 to any other agency of state government, or any county, city, or other state, and shall

25 not be inspected intentionally and without authorization by any present secretary or

26 employee of the Finance and Administration Cabinet, commissioner or employee of

27 the department, or any other person.

- 1 (5) Statistics of crude oil as reported to the Department of Revenue under the crude oil
2 excise tax requirements of KRS Chapter 137 and statistics of natural gas production
3 as reported to the Department of Revenue under the natural resources severance tax
4 requirements of KRS Chapter 143A may be made public by the department by
5 release to the Energy and Environment Cabinet, Department for Natural Resources.
- 6 (6) Notwithstanding any provision of law to the contrary, beginning with mine-map
7 submissions for the 1989 tax year, the department may make public or divulge only
8 those portions of mine maps submitted by taxpayers to the department pursuant to
9 KRS Chapter 132 for ad valorem tax purposes that depict the boundaries of mined-
10 out parcel areas. These electronic maps shall not be relied upon to determine actual
11 boundaries of mined-out parcel areas. Property boundaries contained in mine maps
12 required under KRS Chapters 350 and 352 shall not be construed to constitute land
13 surveying or boundary surveys as defined by KRS 322.010 and any administrative
14 regulations promulgated thereto.
