A BILL

To amend the Food, Agriculture, Conservation, and Trade Act of 1990 to provide research and extension grants to combat plant pests and noxious weeds that impact coffee plants, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Coffee Plant Health
- 5 Initiative Amendments Act".

1 SEC. 2. COFFEE PLANT HEALTH INITIATIVE.

2	(a) In General.—Section 1672(d) of the Food, Ag-
3	riculture, Conservation, and Trade Act of 1990 (7 U.S.C.
4	5925(d)) is amended by striking paragraph (9) and insert-
5	ing the following:
6	"(9) Coffee plant health initiative.—
7	"(A) IN GENERAL.—Research and exten-
8	sion grants may be made under this section for
9	the purposes of—
10	"(i) developing and disseminating
11	science-based tools and treatments to com-
12	bat plant pests and noxious weeds that im-
13	pact coffee plants;
14	"(ii) establishing an areawide inte-
15	grated pest management program in areas
16	affected by, or areas at risk of being af-
17	fected by, plant pests or noxious weeds
18	that impact coffee plants;
19	"(iii) surveying and collecting data on
20	coffee plant production and health;
21	"(iv) investigating coffee plant biol-
22	ogy, immunology, ecology, genomics, and
23	bioinformatics; and
24	"(v) conducting research on—

1	"(I) factors that may contribute
2	to or be associated with coffee plant
3	immune systems;
4	" (Π) other serious threats to cof-
5	fee plants, including the sublethal ef-
6	fects of insecticides, herbicides, and
7	fungicides on insects and plants bene-
8	ficial to coffee plant growth; and
9	"(III) the development of miti-
10	gating and preventative measures to
11	improve habitat conservation and best
12	management practices in coffee-grow-
13	ing regions.
14	"(B) Definition of noxious weed;
15	PLANT PEST.—In this paragraph, the terms
16	'noxious weed' and 'plant pest' have the mean-
17	ings given those terms in section 403 of the
18	Plant Protection Act (7 U.S.C. 7702).".
19	(b) Authorization of Appropriations.—Section
20	1672(h) of the Food, Agriculture, Conservation, and
21	Trade Act of 1990 (7 U.S.C. 5925(h)) is amended by
22	striking "2023" and inserting "2033"
