A BILL

To amend the Federal Fire Prevention and Control Act of 1974 to authorize appropriations for the United States Fire Administration and firefighter assistance grant programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Fire Grants and Safety
3 Act”.

4 **SEC. 2. REAUTHORIZATION OF THE UNITED STATES FIRE**

11 (3) by adding at the end the following:

12 “(N) \$95,000,000 for each of fiscal years 2024
13 through 2030, of which \$3,420,000 for each such
14 fiscal year shall be used to carry out section 8(f).”.
