2 Labor and Employment – Apprenticeships Apprenticeship 2030 Commission and Representation on the Apprenticeship and Training Council

- 4 FOR the purpose of requiring that the Apprenticeship and Training Council and 5 consultants to the Council include representation by individuals who are Asian, 6 Black, and Latino; establishing the Apprenticeship 2030 Commission to examine and 7 make recommendations to expand access to apprenticeship to reduce skill shortages 8 in high-demand occupations and provide affordable training for career pathways for 9 young people in the public and private sectors; requiring the Governor to include 10 certain amounts in certain fiscal years in the annual budget bill for a certain purpose; and generally relating to apprenticeships the Apprenticeship 2030 Commission and 11 12 representation on the Apprenticeship and Training Council.

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 19 That the Laws of Maryland read as follows:

- 2 (b) (1) There is an Apprenticeship and Training Council as part of the Division 3 of Workforce Development and Adult Learning. The Council consists of 12 members all of 4 whom shall be appointed by the Governor of Maryland, with the advice of the Secretary 5 and with the advice and consent of the Senate of Maryland.
- 6 (2) Four of the members shall be representatives of employee 7 organizations; one shall be an employee; five shall be representatives of employers; and two 8 shall be appointed from the general public.
- 9 (3) (I) The membership of the Council shall, to the extent practicable, reflect the geographic, racial, ethnic, cultural, and gender diversity of the State and shall include representation by individuals with disabilities AND INDIVIDUALS WHO ARE ASIAN, BLACK, AND LATINO.
- (II) Consultants to the Council shall, to the extent practicable, reflect the geographic, racial, ethnic, cultural, and gender diversity of the State and shall include representation by individuals with disabilities AND INDIVIDUALS WHO ARE ASIAN, BLACK, AND LATINO.
- 17 (4) In advising the Governor, the Secretary shall give consideration to a 18 balanced geographic representation from all of Maryland and a representative sampling 19 and mix of Maryland industry.
- 20 (5) One member shall be appointed as Chairman by the Governor, with the advice of the Secretary, and serve as Chairman at the pleasure of the Governor. The Assistant State Superintendent, Career and Technology Education, and the Maryland State Director of the Office of Apprenticeship, U.S. Department of Labor, shall serve as consultants to the Council without vote.
- 25 (6) The Governor, with the advice of the Secretary may appoint up to three additional consultants to the Council from the public at large.

AND BE IT FURTHER ENACTED, That, for each of fiscal years 2025 through 2027, the Governor shall include in the annual budget bill an appropriation in the following amounts to the County Executive and County Council of Prince George's County to award grants to a nonprofit entity located in Prince George's County to provide workforce development services to at least 2,000 youth and adults in the community:

 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023. Section 2 of this Act shall remain effective for a period of 1 year and 9 months and, at the end of June 30, 2025, Section 2 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted. Section 2 of this Act shall remain effective through December 31, 2024, and, at the end of December 31, 2024, Section 2 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
