## A BILL

To amend the Older Americans Act of 1965 in order to address the needs of caregivers, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Supporting America's
- 5 Caregivers and Families Act".
- 6 SEC. 2. ADDRESSING THE NEEDS OF CAREGIVERS.
- 7 (a) Authorization of Appropriations for Fam-
- 8 ILY CAREGIVER SUPPORT.—Section 303(e) of the Older
- 9 Americans Act of 1965 (42 U.S.C. 3023(e)) is amended
- 10 by striking "\$154,336,482" and all that follows through

1	the period at the end and inserting "\$360,000,000 for
2	each of fiscal years 2020 through 2024".
3	(b) Improving Caregiver Assessment.—
4	(1) Increasing use of caregiver assess-
5	MENT TOOLS.—Section 202 of the Older Americans
6	Act of 1965 (42 U.S.C. 3012) is amended by adding
7	at the end the following:
8	"(h) By not later than January 1, 2021, the Assist-
9	ant Secretary shall—
10	"(1) in consultation with caregivers, older indi-
11	viduals, the aging network, and other experts and
12	stakeholders, develop and implement a strategy to
13	increase the use of comprehensive caregiver assess-
14	ment tools that—
15	"(A) are standardized across a planning
16	and service area;
17	"(B) assess the specific problems, needs,
18	strengths, and resources of caregivers—
19	"(i) as identified by a recognized care-
20	giver, as appropriate, through voluntary
21	participation;
22	"(ii) through direct contact with the
23	caregiver, which may include in-person,
24	phone, or online contact; and

1	"(iii) at appropriate intervals, includ-
2	ing to accommodate significant changes in
3	the caregiving situation;
4	"(C) determine whether a caregiver would
5	benefit from support services; and
6	"(D) lead to providing targeted caregiver
7	support services to best benefit caregivers,
8	where appropriate and available based upon
9	identified unmet needs, including through refer-
10	rals;
11	"(2) conduct a study on the best practices and
12	potential considerations regarding mandatory use of
13	comprehensive caregiver assessment tools standard-
14	ized across a planning and service area by an area
15	agency on aging, which shall examine—
16	"(A) the current use of caregiver assess-
17	ments, as of the date of the study;
18	"(B) the efficacy and feasibility of manda-
19	tory use of comprehensive caregiver assessment
20	tools standardized across a planning and service
21	area, including the value to caregivers and the
22	older individuals to whom they provide care;
23	and
24	"(C) the potential impact on the aging net-
25	work of using such assessments; and

1	"(3) prepare and submit to Congress a report
2	regarding the study under paragraph (2) that pro-
3	vides recommendations for the appropriate use of
4	comprehensive caregiver assessments standardized
5	across a planning and service area by an area agen-
6	cy on aging, and a proposed budget, based on the
7	Assistant Secretary's professional judgment, for ap-
8	propriately implementing the recommendations.".
9	(2) Assessing needs of caregivers.—Sec-
10	tion 373(e)(3) of the Older Americans Act of 1965
11	(42 U.S.C. $3030s-1(e)(3)$ ) is amended by inserting
12	"assess the needs of family caregivers or older rel-
13	ative caregivers and" before "provide".
14	(3) Family caregiver resource center
15	AND TECHNICAL ASSISTANCE.—Section 202(b) of
16	the Older Americans Act of 1965 (42 U.S.C.
17	3012(b)) is amended—
18	(A) in paragraph (10), by striking "and"
19	after the semicolon;
20	(B) by redesignating paragraph (11) as
21	paragraph (12); and
22	(C) by inserting after paragraph (10) the
23	following:

1	"(11) establish and operate the National Fam-
2	ily Caregiver Resource and Technical Assistance
3	Center, which will—
4	"(A) by grant or contract with a public or
5	private nonprofit entity, provide information
6	and assistance to State agencies, area agencies
7	on aging, and community-based service pro-
8	viders funded under this Act, including—
9	"(i) through technical assistance, re-
10	search, training, program analysis, and
11	data collection;
12	"(ii) activities described in section
13	411(a)(11); and
14	"(iii) dissemination of best practices,
15	including best practices for conducting as-
16	sessments of caregiver needs using com-
17	prehensive assessment tools standardized
18	across a planning and service area; and
19	"(B) directly or through grant or contract,
20	provide information, education, and assistance
21	to family caregivers in a manner that is acces-
22	sible and understandable to the family care-
23	givers.".
24	(c) Business Acumen Provisions.—

1	(1) Assistance relating to growing and
2	SUSTAINING CAPACITY.—Section 202(b)(9) of the
3	Older Americans Act of 1965 (42 U.S.C.
4	3012(b)(9)) is amended—
5	(A) in subparagraph (A), by striking
6	"and" after the semicolon;
7	(B) in subparagraph (B), by inserting
8	"and" after the semicolon; and
9	(C) by adding at the end the following:
10	"(C) business acumen, capacity building,
11	organizational development, innovation, and
12	other methods of growing and sustaining the
13	capacity of the aging network to serve older
14	adults and caregivers most effectively;".
15	(2) Clarifying partnerships for area
16	AGENCIES ON AGING.—Section 306 of the Older
17	Americans Act of 1965 (42 U.S.C. 3026) is amend-
18	ed by adding at the end the following:
19	"(g) Nothing in this Act shall restrict an area agency
20	on aging from providing services not provided or author-
21	ized under this Act, including through—
22	"(1) contracts with health care payers;
23	"(2) consumer private pay programs; or
24	"(3) other arrangements with entities or indi-
25	viduals that increase the availability of home and

on aging.".
