Mr. Thompson of California (for himself, Mr. Nadler, Mr. Upton, Ms. Jackson Lee, Mr. Smith of New Jersey, Ms. Kelly of Illinois, Mr. Fitzpatrick, and Mrs. McBath) introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To require a background check for every firearm sale.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Bipartisan Back-
- 5 ground Checks Act of 2021".
- 6 SEC. 2. PURPOSE.
- 7 The purpose of this Act is to utilize the current back-
- 8 ground checks process in the United States to ensure indi-
- 9 viduals prohibited from gun possession are not able to ob-
- 10 tain firearms.

1 SEC. 3. FIREARMS TRANSFERS.

- 2 (a) In General.—Section 922 of title 18, United
- 3 States Code, is amended by adding at the end the fol-
- 4 lowing:
- 5 "(aa)(1)(A) It shall be unlawful for any person who
- 6 is not a licensed importer, licensed manufacturer, or li-
- 7 censed dealer to transfer a firearm to any other person
- 8 who is not so licensed, unless a licensed importer, licensed
- 9 manufacturer, or licensed dealer has first taken possession
- 10 of the firearm for the purpose of complying with sub-
- 11 section (t).
- "(B) Upon taking possession of a firearm under sub-
- 13 paragraph (A), a licensee shall comply with all require-
- 14 ments of this chapter as if the licensee were transferring
- 15 the firearm from the inventory of the licensee to the unli-
- 16 censed transferee.
- 17 "(C) If a transfer of a firearm described in subpara-
- 18 graph (A) will not be completed for any reason after a
- 19 licensee takes possession of the firearm (including because
- 20 the transfer of the firearm to, or receipt of the firearm
- 21 by, the transferee would violate this chapter), the return
- 22 of the firearm to the transferor by the licensee shall not
- 23 constitute the transfer of a firearm for purposes of this
- 24 chapter.
- 25 "(2) Paragraph (1) shall not apply to—

"(A) a law enforcement agency or any law enforcement officer, armed private security professional, or member of the armed forces, to the extent the officer, professional, or member is acting within the course and scope of employment and official duties;

> "(B) a transfer that is a loan or bona fide gift between spouses, between domestic partners, between parents and their children, including step-parents and their step-children, between siblings, between aunts or uncles and their nieces or nephews, or between grandparents and their grandchildren, if the transferor has no reason to believe that the transferee will use or intends to use the firearm in a crime or is prohibited from possessing firearms under State or Federal law;

> "(C) a transfer to an executor, administrator, trustee, or personal representative of an estate or a trust that occurs by operation of law upon the death of another person;

> "(D) a temporary transfer that is necessary to prevent imminent death or great bodily harm, including harm to self, family, household members, or others, if the possession by the transferee lasts only as long as immediately necessary to prevent the im-

1	minent death or great bodily harm, including the
2	harm of domestic violence, dating partner violence,
3	sexual assault, stalking, and domestic abuse;
4	"(E) a transfer that is approved by the Attor-
5	ney General under section 5812 of the Internal Rev-
6	enue Code of 1986; or
7	"(F) a temporary transfer if the transferor has
8	no reason to believe that the transferee will use or
9	intends to use the firearm in a crime or is prohibited
10	from possessing firearms under State or Federal
11	law, and the transfer takes place and the trans-
12	feree's possession of the firearm is exclusively—
13	"(i) at a shooting range or in a shooting
14	gallery or other area designated for the purpose
15	of target shooting;
16	"(ii) while reasonably necessary for the
17	purposes of hunting, trapping, or fishing, if the
18	transferor—
19	"(I) has no reason to believe that the
20	transferee intends to use the firearm in a
21	place where it is illegal; and
22	"(II) has reason to believe that the
23	transferee will comply with all licensing
24	and permit requirements for such hunting,
25	trapping, or fishing; or

1	"(iii) while in the presence of the trans-
2	feror.
3	"(3) It shall be unlawful for a licensed importer, li-
4	censed manufacturer, or licensed dealer to transfer posses-
5	sion of, or title to, a firearm to another person who is
6	not so licensed unless the importer, manufacturer, or deal-
7	er has provided such other person with a notice of the
8	prohibition under paragraph (1), and such other person
9	has certified that such other person has been provided
10	with this notice on a form prescribed by the Attorney Gen-
11	eral.".
12	(b) Amendment to Section 924(a).—Section
13	924(a)(5) of title 18, United States Code, is amended by
14	striking "(s) or (t)" and inserting "(s), (t), or (aa)".
15	(c) Rules of Interpretation.—Nothing in this
16	Act, or any amendment made by this Act, shall be con-
17	strued to—
18	(1) authorize the establishment, directly or indi-
19	rectly, of a national firearms registry; or
20	(2) interfere with the authority of a State,
21	under section 927 of title 18, United States Code,
22	to enact a law on the same subject matter as this
23	Act

- 1 (d) Effective Date.—The amendment made by
- 2 subsections (a) and (b) shall take effect 180 days after

3 the date of enactment of this Act.
