## "§ 7A-354.2. Human trafficking reporting and response system.

The North Carolina Human Trafficking Commission shall coordinate and support the development or use of a secure, technology-driven, and survivor-centered human trafficking reporting and response system, with a focus on areas of the State where access to anti-human trafficking resources is most limited."

**SECTION 2.(a)** There is appropriated from the General Fund to the Administrative Office of the Courts, North Carolina Human Trafficking Commission, the sum of three hundred thousand dollars (\$300,000) in recurring funds for the 2025-2026 fiscal year to be used to coordinate and support the development or use of a secure, technology-driven, and survivor-centered human trafficking reporting and response system, with a targeted focus on western North Carolina, where access to anti-human trafficking resources remains extremely limited.

**SECTION 2.(b)** The uses for the funds appropriated in this section may include, but are not limited to, each of the following:

- (1) Expanding the reach of a reporting and response system, as referenced in subsection (a) of this section, in western North Carolina.
- (2) Funding one full-time regional operations coordinator to perform at a minimum each of the following job functions in relation to the reporting and response system required to be developed or used pursuant to G.S. 7A-354.2:
