A BILL

To direct the Secretary of Homeland Security to develop and disseminate best practices for rental companies and dealers to report suspicious behavior to law enforcement agencies at the point of sale of a covered rental vehicle to prevent and mitigate acts of terrorism using motor vehicles, and for other purposes.

- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Darren Drake Act".

1	SEC. 2. BEST PRACTICES RELATED TO CERTAIN INFORMA-
2	TION COLLECTED BY RENTAL COMPANIES
3	AND DEALERS.
4	(a) Development and Dissemination.—
5	(1) In general.—Not later than one year
6	after the date of the enactment of this Act, the Sec-
7	retary of Homeland Security shall develop and dis-
8	seminate best practices for rental companies and
9	dealers to report suspicious behavior to law enforce-
10	ment agencies at the point of sale of a covered rental
11	vehicle.
12	(2) Consultation; updates.—The Secretary
13	shall develop and, as necessary, update the best
14	practices described in paragraph (1) after consulta-
15	tion with relevant rental industry stakeholders.
16	(b) Report to Congress.—Not later than one year
17	after the date of the enactment of this Act, the Secretary
18	of Homeland Security shall submit to Congress a report
19	on the implementation of this section, including an assess-
20	ment of—
21	(1) the impact of the best practices described in
22	subsection (a) on efforts to protect the United
23	States against terrorist attacks; and
24	(2) ways to improve and expand cooperation
25	and angagement hetween_

1	(A) the Department of Homeland Security
2	and
3	(B) rental companies, dealers, and other
4	relevant rental industry stakeholders.
5	(c) Definitions.—In this section:
6	(1) The terms "dealer" and "rental company"
7	have the meanings given those terms in section
8	30102 of title 49, United States Code.
9	(2) The term "covered rental vehicle" means a
10	motor vehicle that—
11	(A) is rented without a driver for an initial
12	term of less than 4 months; and
13	(B) is part of a motor vehicle fleet of 35
14	or more motor vehicles that are used for rental
15	purposes by a rental company.
