13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

17 18	(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
19	(2) "DEPARTMENT" MEANS THE DEPARTMENT OF COMMERCE.
20	(3) "QUALIFIED EXPENSES" MEANS ANY OF THE FOLLOWING

EXPENSES PAID OR INCURRED BY AN INDIVIDUAL DURING ANY PERIOD OF

1	(I) FOOD AND BEVERAGE EXPENSES;
2 3	(II) LODGING EXPENSES, OTHER THAN EXPENSES RELATED TO LODGING AT A VACATION HOME THAT IS OWNED BY THE INDIVIDUAL;
4 5	(III) TRANSPORTATION EXPENSES, PROVIDED THAT THE CREDIT FOR MILES DRIVEN IN THE INDIVIDUAL'S PRIVATELY OWNED VEHICLE IS
6 7	CALCULATED USING THE PRIVATELY OWNED VEHICLE REIMBURSEMENT RATES IN EFFECT FOR STATE EMPLOYEES;
8 9	(IV) EXPENSES FOR LIVE ENTERTAINMENT AND SPORTING EVENTS; OR
10 11	(V) EXPENSES RELATED TO ATTENDING A CONFERENCE OR BUSINESS MEETING.
12	(4) "QUALIFIED TRAVEL" MEANS ANY TRAVEL:
13 14	(I) THAT OCCURS WITHIN THE STATE AFTER DECEMBER 31, 2021, BUT BEFORE JANUARY 1, 2024; AND
15 16	(II) FOR WHICH THE FINAL DESTINATION IS AT LEAST ${\bf 50}$ MILES FROM THE PRINCIPAL RESIDENCE OF THE INDIVIDUAL.
17 18 19 20	(B) FOR A TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2021, BUT BEFORE JANUARY 1, 2024, AN INDIVIDUAL MAY CLAIM A CREDIT AGAINST THE STATE INCOME TAX IN THE AMOUNT STATED ON THE TAX CREDIT CERTIFICATE ISSUED UNDER SUBSECTION (D) OF THIS SECTION.
21 22	(C) (1) FOR EACH TAXABLE YEAR, THE CREDIT ALLOWED UNDER THIS SECTION MAY NOT EXCEED THE LESSER OF:
23 24	(i) 100% of the qualified expenses paid or incurred by the individual during the taxable year; or
25	(II) THE SUM OF:
26	1. A. \$500 FOR AN INDIVIDUAL; OR
27 28	B. \$1,000 FOR A MARRIED COUPLE FILING A JOINT TAX RETURN; AND

- 2. AN AMOUNT EQUAL TO THE PRODUCT OF \$100 2 MULTIPLIED BY THE NUMBER OF DEPENDENT CHILDREN OF THE INDIVIDUAL.
- 3 (2) A CREDIT MAY NOT BE ALLOWED UNDER THIS SECTION WITH 4 RESPECT TO ANY QUALIFIED EXPENSES FOR WHICH THE INDIVIDUAL CLAIMED A DEDUCTION UNDER § 162(A)(2) OF THE INTERNAL REVENUE CODE.
- 6 (3) IF THE CREDIT ALLOWED UNDER THIS SECTION IN ANY TAXABLE YEAR EXCEEDS THE STATE INCOME TAX FOR THAT TAXABLE YEAR, THE UNUSED AMOUNT OF THE CREDIT MAY NOT BE CARRIED OVER TO ANY OTHER TAXABLE YEAR.
- 9 **(D) (1)** SUBJECT TO THE LIMITATIONS OF THIS SUBSECTION, ON APPLICATION BY AN INDIVIDUAL, THE DEPARTMENT SHALL ISSUE A TAX CREDIT CERTIFICATE IN THE AMOUNT ALLOWABLE UNDER SUBSECTION (C) OF THIS SECTION.
- 13 (2) THE APPLICATION SHALL BE IN THE FORM AND CONTAIN THE 14 INFORMATION THAT THE DEPARTMENT REQUIRES.
- 15 (3) THE DEPARTMENT SHALL:
- 16 (I) APPROVE ALL APPLICATIONS THAT QUALIFY FOR A TAX
 17 CREDIT CERTIFICATE UNDER THIS SUBSECTION ON A FIRST-COME, FIRST-SERVED
 18 BASIS; AND
- 19 (II) NOTIFY THE INDIVIDUAL WITHIN 30 DAYS AFTER THE 20 RECEIPT OF THE APPLICATION OF THE DEPARTMENT'S APPROVAL OR DENIAL OF 21 THE APPLICATION.
- 22 (4) FOR ANY TAXABLE YEAR, THE TOTAL AMOUNT OF CREDIT 23 CERTIFICATES ISSUED BY THE DEPARTMENT UNDER THIS SUBSECTION MAY NOT 24 EXCEED \$3,200,000.
- 25 (E) ON OR BEFORE JANUARY 31 EACH TAXABLE YEAR, THE DEPARTMENT SHALL REPORT TO THE COMPTROLLER ON THE TAX CREDIT CERTIFICATES ISSUED UNDER THIS SECTION DURING THE PRIOR TAXABLE YEAR.
- 28 **(F)** THE DEPARTMENT AND THE COMPTROLLER JOINTLY SHALL ADOPT 29 REGULATIONS TO:
- 30 (1) IMPLEMENT THE PROVISIONS OF THIS SECTION; AND
- 31 (2) SPECIFY CRITERIA AND PROCEDURES FOR THE APPLICATION

- FOR, APPROVAL OF, AND MONITORING OF CONTINUING ELIGIBILITY FOR THE TAX CREDIT UNDER THIS SECTION.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 4 1, 2022. It shall remain effective for a period of 2 years and, at the end of June 30, 2024,
- 5 this Act, with no further action required by the General Assembly, shall be abrogated and
- 6 of no further force and effect.
