- 8 (IV) ANY OTHER GOVERNMENT EMPLOYEE OR CONTRACTOR 9 WHO IS AUTHORIZED TO RECEIVE REPORTS OF A CRIME OR AN EMERGENCY.

 20 INJURY OR SEVERE EMOTIONAL DISTRESS TO A PERSON OR THE DEATH OF A PERSON
 21 AS A PROXIMATE RESULT OF LAWFUL CONDUCT ARISING OUT OF THE RESPONSE.

- 10 (3) THE COUNTY IN WHICH A GOVERNMENTAL EMERGENCY REPORT RECIPIENT RESPONDED TO THE STATEMENT, REPORT, OR COMPLAINT.

AND BE IT FURTHER ENACTED, That, if any provision of this Act or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Act that can be given effect without the invalid provision or application, and for this purpose the provisions of this Act are declared severable.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 October 1, 2023.
