A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – West Baltimore County Redevelopment Authority**

3 FOR the purpose of authorizing Baltimore County to exercise powers to acquire, develop or
4 redevelop, and dispose of certain land or property located in West Baltimore County
5 for residential, commercial, or industrial purposes; authorizing the County
6 Executive and County Council of Baltimore County to establish, by law, the West
7 Baltimore County Redevelopment Authority and to delegate certain powers to the
8 Authority to acquire, develop, redevelop, or dispose of certain land or property
9 located in West Baltimore County for certain purposes; authorizing the Authority to
10 issue certain bonds and other evidences of indebtedness and authorizing the county
11 to guarantee these obligations; establishing certain penalties for violations of the
12 regulations of the Authority; and generally relating to the West Baltimore County
13 Redevelopment Authority.

20 Preamble

21 WHEREAS, There exist within Baltimore County a number of areas in need of
22 residential, commercial, or industrial development or redevelopment in furtherance of the
23 public interest; and

24 WHEREAS, Those areas include both areas that are considered slum or blighted
25 areas, and areas that are not subject to deteriorated or deteriorating conditions, but which
26 are in need of development or redevelopment for the public benefit; and

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 WHEREAS, In order to revitalize these areas of the county it is necessary that the
2 county be authorized to acquire, by any legal means, including by exercise of the power of
3 eminent domain, land or property for residential, commercial, or industrial development or
4 redevelopment, to develop or redevelop land or property for residential, commercial, or
5 industrial purposes, and to dispose of land or property for residential, commercial, or
6 industrial development or redevelopment under certain circumstances; and

7 WHEREAS, In order to revitalize these areas of the county it also is necessary that
8 the county have the power to establish a separate authority whose purpose will be to
9 facilitate land or property acquisition, development or redevelopment, and disposition for
10 residential, commercial, and industrial purposes in furtherance of the public interest; and

11 WHEREAS, In order to accomplish the purposes of this subtitle it is necessary to
12 authorize the county to delegate to such separate authority the authority to acquire, by any
13 legal means, including by exercise of the power of eminent domain, land or property for
14 residential, commercial, or industrial development or redevelopment, to develop or
15 redevelop land or property for residential, commercial, or industrial purposes, and to
16 dispose of land or property for residential, commercial, or industrial development or
17 redevelopment under certain circumstances; and

18 WHEREAS, The revitalization of areas within the county in need of residential,
19 commercial, or industrial development or redevelopment is an essential governmental
20 function, and is a public use which will confer a public benefit on the citizens of the county
21 by relieving conditions of unemployment, encouraging the increase of industry and
22 commerce and a balanced economy, assisting in the retention of existing industry and
23 commerce and in the attracting of new industry and commerce, promoting economic
24 development and growth, and generally promoting the health, welfare, and safety of the
25 residents of the county; and

26 WHEREAS, The exercise by the county or the authority which the county is
27 authorized to establish of the power of eminent domain in accordance with this subtitle in
28 order to provide an impetus which private enterprise cannot provide is hereby declared to
29 be for a public use; and

30 WHEREAS, The powers granted pursuant to this subtitle shall be regarded as
31 supplemental and additional to powers conferred by other laws, and may not be regarded
32 as in derogation of any powers now existing; and

33 WHEREAS, This subtitle is necessary for the revitalization of Baltimore County and
34 the public interest of its citizens and shall be liberally construed to effect its purpose; and

35 WHEREAS, The necessity in the public interest for the provisions hereinafter
36 enacted is hereby declared as a matter of legislative determination; now, therefore,

37 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
38 That the Laws of Maryland read as follows:

Article – Economic Development

**SUBTITLE 8. BALTIMORE COUNTY – WEST BALTIMORE COUNTY REDEVELOPMENT
AUTHORITY.**

**(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
INDICATED.**

**(B) “AUTHORITY” MEANS THE WEST BALTIMORE COUNTY
REDEVELOPMENT AUTHORITY ESTABLISHED UNDER THIS SUBTITLE.**

**(C) “BOND” OR “BONDS” MEANS REVENUE BONDS OR NOTES, INCLUDING
BOND ANTICIPATION NOTES AND NOTES IN THE NATURE OF COMMERCIAL PAPER,
OR OTHER INSTRUMENTS, CERTIFICATES, OR EVIDENCES OF OBLIGATION ISSUED
AND SOLD OR OFFERED FOR SALE BY THE REDEVELOPMENT AUTHORITY,
INCLUDING REFUNDING OBLIGATIONS.**

(D) “COST” MEANS THE COST OR EXPENSE ASSOCIATED WITH:

**(1) ALL LAND, PROPERTY, RIGHTS, EASEMENTS, FRANCHISES, AND
LICENSES OR INTERESTS THEREIN DEEMED NECESSARY FOR ANY UNDERTAKING
AUTHORIZED BY THIS SUBTITLE;**

**(2) ALL LABOR, MATERIALS, MACHINERY, FURNISHINGS, AND
EQUIPMENT;**

(3) FINANCING CHARGES;

(4) ESTABLISHMENT OF RESERVES;

**(5) INTEREST PRIOR TO AND DURING CONSTRUCTION AND FOR A
REASONABLE PERIOD AFTER COMPLETION OF CONSTRUCTION;**

(6) ENGINEERING, ARCHITECTURAL, AND LEGAL SERVICES;

**(7) PLANS, SPECIFICATIONS, SURVEYS, ESTIMATES OF COSTS AND OF
REVENUES, AND OTHER EXPENSES NECESSARY OR INCIDENT TO DETERMINING THE
FEASIBILITY OR PRACTICALITY OF ANY LAND OR PROPERTY ACQUISITION OR ANY
DEVELOPMENT OR REDEVELOPMENT PROJECT;**

(8) ADMINISTRATIVE EXPENSES;

(9) LETTERS OR LINES OF CREDIT, MUNICIPAL BOND INSURANCE, OR ANY OTHER FORM OF FINANCIAL GUARANTY OR SURETY;

(10) WORKING CAPITAL; AND

(11) OTHER EXPENSES AS MAY BE NECESSARY OR INCIDENTAL TO THE ACQUISITION OF LAND OR PROPERTY, OR THE DEVELOPMENT OR REDEVELOPMENT, INCLUDING THE COMPREHENSIVE RENOVATION OR REHABILITATION, OF LAND OR PROPERTY IN ACCORDANCE WITH THIS SUBTITLE.

(E) "COUNTY" MEANS BALTIMORE COUNTY.

(F) "WEST BALTIMORE COUNTY" MEANS THE GEOGRAPHIC AREA OF BALTIMORE COUNTY WITHIN THE BOUNDARY LINE OF LIBERTY ROAD IN THE NORTH, BALTIMORE NATIONAL PIKE IN THE SOUTH, ROLLING ROAD IN THE WEST, AND THE LINE BETWEEN BALTIMORE COUNTY AND BALTIMORE CITY IN THE EAST, ALONG WITH ALL CONTIGUOUS PARCELS FOR ONE BLOCK, EXCEPT AT THE BOUNDARY LINE BETWEEN BALTIMORE COUNTY AND BALTIMORE CITY.

THIS SUBTITLE APPLIES ONLY IN BALTIMORE COUNTY.

12-803.

(A) IN ADDITION TO POWERS GRANTED BY LAW, THE COUNTY IS AUTHORIZED, AS SPECIFIED BY LOCAL LAW:

(1) TO ACQUIRE, WITHIN THE BOUNDARY LINES OF WEST BALTIMORE COUNTY, LAND AND PROPERTY OF EVERY KIND, AND ANY RIGHT, INTEREST, FRANCHISE, EASEMENT, OR PRIVILEGE IN THE PROPERTY, BY PURCHASE, LEASE, GIFT, CONDEMNATION, OR ANY OTHER LEGAL MEANS, FOR RESIDENTIAL, COMMERCIAL, OR INDUSTRIAL DEVELOPMENT OR REDEVELOPMENT, INCLUDING COMPREHENSIVE RENOVATION OR REHABILITATION OF THE LAND OR PROPERTY;

(2) TO DEVELOP OR REDEVELOP, INCLUDING THE COMPREHENSIVE RENOVATION OR REHABILITATION OF, ANY LAND OR PROPERTY ACQUIRED BY ANY OF THE METHODS DESCRIBED UNDER ITEM (1) OF THIS SUBSECTION; AND

(3) TO SELL, LEASE, CONVEY, TRANSFER, OR OTHERWISE DISPOSE OF ANY OF THE LAND OR PROPERTY, REGARDLESS OF WHETHER THE LAND OR PROPERTY HAS BEEN DEVELOPED, REDEVELOPED, ALTERED, OR IMPROVED AND

1 IRRESPECTIVE OF THE MANNER OR MEANS IN OR BY WHICH THE LAND OR PROPERTY
2 MAY HAVE BEEN ACQUIRED, TO ANY PRIVATE, PUBLIC, OR QUASI-PUBLIC
3 CORPORATION, PARTNERSHIP, ASSOCIATION, PERSON, OR OTHER LEGAL ENTITY
4 FOR RESIDENTIAL, COMMERCIAL, OR INDUSTRIAL DEVELOPMENT OR
5 REDEVELOPMENT, INCLUDING COMPREHENSIVE RENOVATION OR REHABILITATION
6 OF THE LAND OR PROPERTY.

7 (B) LAND OR PROPERTY TAKEN BY THE COUNTY FOR ANY OF THE PURPOSES
8 DESCRIBED UNDER SUBSECTION (A) OF THIS SECTION OR IN CONNECTION WITH THE
9 EXERCISE OF ANY OF THE POWERS THAT MAY BE GRANTED TO THE COUNTY UNDER
10 THIS SECTION, OR BY ANY POWERS CONFERRED BY ADDITIONAL LAWS BY
11 EXERCISING THE POWER OF EMINENT DOMAIN, MAY NOT BE TAKEN WITHOUT JUST
12 COMPENSATION, AS AGREED ON BETWEEN THE PARTIES OR AWARDED BY A JURY,
13 BEING FIRST PAID OR TENDERED TO THE PARTY ENTITLED TO THAT
14 COMPENSATION.

15 (C) ALL LAND OR PROPERTY NEEDED, OR TAKEN BY THE EXERCISE OF THE
16 POWER OF EMINENT DOMAIN, BY THE COUNTY FOR ANY OF THE PURPOSES
17 DESCRIBED UNDER SUBSECTION (A) OF THIS SECTION OR IN CONNECTION WITH THE
18 EXERCISE OF ANY OF THE POWERS THAT MAY BE GRANTED TO THE COUNTY UNDER
19 THIS SECTION SHALL BE DEEMED TO BE NEEDED OR TAKEN FOR A PUBLIC USE OR A
20 PUBLIC BENEFIT.

21 (D) LAND OR PROPERTY OWNED BY THE FEDERAL GOVERNMENT, THE
22 STATE, OR A LOCAL GOVERNMENT, OR AN AGENCY OF THE FEDERAL GOVERNMENT,
23 THE STATE, OR A LOCAL GOVERNMENT, MAY NOT BE ACQUIRED BY THE COUNTY BY
24 EXERCISE OF THE POWER OF EMINENT DOMAIN WITHOUT THE PRIOR CONSENT OF
25 THE GOVERNMENT OR AGENCY THAT OWNS THE LAND OR PROPERTY.

26 12-804.

27 (A) THE COUNTY MAY ESTABLISH, BY LAW, A BODY CORPORATE AND
28 POLITIC AND AN INSTRUMENTALITY OF THE COUNTY TO BE KNOWN AS THE "WEST
29 BALTIMORE COUNTY REDEVELOPMENT AUTHORITY".

30 (B) THE AUTHORITY SHALL BE CREATED WHEN THE COUNTY:

31 (1) ENACTS LOCAL LAWS PROVIDING AND CONSTITUTING THE TERMS
32 OF THE CHARTER FOR THE AUTHORITY; AND

33 (2) FILES THE CHARTER WITH:

34 (I) THE STATE DEPARTMENT OF ASSESSMENTS AND

1 TAXATION;

2 (II) THE DEPARTMENT OF LEGISLATIVE SERVICES; AND

3 (III) THE SECRETARY OF STATE.

4 (C) ON THE ADVICE OF THE AUTHORITY MEMBERS DESCRIBED UNDER
5 SUBSECTION(D)(1) THROUGH (5) OF THIS SECTION, THE COUNTY MAY:

6 (1) AMEND THE AUTHORITY'S CHARTER THROUGH LOCAL LAW IF THE
7 AMENDMENTS ARE FILED WITH THE STATE DEPARTMENT OF ASSESSMENTS AND
8 TAXATION, THE DEPARTMENT OF LEGISLATIVE SERVICES, AND THE SECRETARY OF
9 STATE;

10 (2) ALTER THE STRUCTURE, ORGANIZATION, PROGRAM, POWERS, OR
11 ACTIVITY OF THE AUTHORITY, UNLESS THE ALTERATION WOULD IMPAIR THE
12 AUTHORITY'S OBLIGATIONS UNDER A CONTRACT OR AN AGREEMENT THAT THE
13 AUTHORITY ENTERED INTO BEFORE THE ALTERATION; AND

14 (3) TERMINATE THE AUTHORITY, UNLESS THE TERMINATION WOULD
15 IMPAIR THE AUTHORITY'S OBLIGATIONS UNDER A CONTRACT OR AN AGREEMENT
16 THAT THE AUTHORITY ENTERED INTO BEFORE TERMINATION.

17 (D) THE AUTHORITY SHALL CONSIST OF THE FOLLOWING MEMBERS:

18 (1) EACH MEMBER OF THE SENATE OF MARYLAND WHOSE
19 LEGISLATIVE DISTRICT INCLUDES A PORTION OF WEST BALTIMORE COUNTY;

20 (2) ONE MEMBER OF THE HOUSE OF DELEGATES FROM EACH
21 LEGISLATIVE DISTRICT THAT INCLUDES A PORTION OF WEST BALTIMORE COUNTY,
22 DESIGNATED BY THE SPEAKER OF THE HOUSE;

23 (3) EACH COUNCIL PERSON WHOSE DISTRICT INCLUDES A PORTION
24 OF WEST BALTIMORE COUNTY;

25 (4) THE COUNTY ADMINISTRATIVE OFFICER;

26 (5) ONE MEMBER APPOINTED BY THE COUNTY EXECUTIVE OF
27 BALTIMORE COUNTY; AND

28 (6) ELEVEN MEMBERS APPOINTED BY THE COUNTY FROM A SLATE OF
29 INDIVIDUALS PREPARED BY THE AUTHORITY MEMBERS DESCRIBED UNDER ITEMS
30 (1) THROUGH (5) OF THIS SUBSECTION.

(E) THE SLATE OF INDIVIDUALS DESCRIBED UNDER SUBSECTION(D)(6) OF THIS SECTION SHALL BE DECIDED BY A MAJORITY VOTE OF THE AUTHORITY MEMBERS DESCRIBED UNDER SUBSECTION(D)(1) THROUGH (5) OF THIS SECTION.

12-805.

(A) SUBJECT TO § 12-804(D) OF THIS SUBTITLE, THE NUMBER, RESIDENCY REQUIREMENTS, MEANS OF APPOINTMENT AND REMOVAL, QUALIFICATIONS, AND TERMS OF OFFICE OF THE MEMBERS OF THE AUTHORITY SHALL BE AS SPECIFIED BY THE COUNTY AND BASED ON THE RECOMMENDATION OF THE AUTHORITY MEMBERS DESCRIBED UNDER § 12-804(D)(1) THROUGH (5) OF THIS SUBTITLE.

(B) THE OFFICERS, EMPLOYEES, AND AGENTS OF THE AUTHORITY SHALL BE APPOINTED AND REMOVED AS SPECIFIED BY LOCAL LAW.

(C) THE EXERCISE OF ALL POWERS, AUTHORITY, RIGHTS, AND OBLIGATIONS OF THE AUTHORITY SHALL BE AS SPECIFIED BY THIS SUBTITLE AND LOCAL LAW.

(D) AN ACT OF THE AUTHORITY MAY NOT BE CHALLENGED ON THE BASIS OF THE ABSENCE OF QUALIFICATIONS OF A MEMBER OF THE AUTHORITY IF THE MEMBER:

(1) HAS BEEN APPOINTED BY THE APPROPRIATE AUTHORITY DESIGNATED BY LOCAL LAW; AND

(2) HAS TAKEN THE OATH OF OFFICE.

(A) EXCEPT AS PROVIDED IN SUBSECTION (E) OF THIS SECTION, THE COUNTY IS AUTHORIZED, BY LAW, TO DELEGATE TO THE AUTHORITY ANY OR ALL OF THE POWERS GRANTED TO THE COUNTY UNDER § 12-803 OF THIS SUBTITLE.

(B) LAND OR PROPERTY TAKEN BY THE AUTHORITY IN ACCORDANCE WITH A DELEGATION OF AUTHORITY FROM THE COUNTY BY EXERCISE OF THE POWER OF EMINENT DOMAIN MAY NOT BE TAKEN WITHOUT JUST COMPENSATION, AS AGREED ON BETWEEN THE PARTIES OR AWARDED BY A JURY, BEING FIRST PAID OR TENDERED TO THE PARTY ENTITLED TO THAT COMPENSATION.

(C) ALL LAND OR PROPERTY NEEDED, OR TAKEN BY THE EXERCISE OF THE POWER OF EMINENT DOMAIN, BY THE AUTHORITY IN ACCORDANCE WITH A

1 DELEGATION OF AUTHORITY FROM THE COUNTY SHALL BE DEEMED TO BE NEEDED
2 OR TAKEN FOR A PUBLIC USE OR A PUBLIC BENEFIT.

3 (D) LAND OR PROPERTY OWNED BY THE FEDERAL GOVERNMENT, THE
4 STATE, OR A LOCAL GOVERNMENT, OR AN AGENCY OF THE FEDERAL GOVERNMENT,
5 THE STATE, OR A LOCAL GOVERNMENT, MAY NOT BE ACQUIRED BY THE AUTHORITY
6 BY EXERCISE OF THE POWER OF EMINENT DOMAIN WITHOUT THE PRIOR CONSENT
7 OF THE GOVERNMENT OR AGENCY OWNING THE LAND OR PROPERTY.

8 (E) NOTWITHSTANDING THE DELEGATION OF THE POWER OF EMINENT
9 DOMAIN BY THE COUNTY TO THE AUTHORITY, A DECISION OF THE AUTHORITY TO
10 TAKE OWNER-OCCUPIED RESIDENTIAL REAL PROPERTY SHALL BE FIRST APPROVED
11 BY THE COUNTY COUNCIL AFTER NOTICE TO THE PROPERTY OWNER.

12 12-807.

13 (A) FOR THE PUBLIC PURPOSES DESCRIBED UNDER § 12-803 OF THIS
14 SUBTITLE AND SUBJECT TO LOCAL LAW AND THE PROVISIONS OF THIS SUBTITLE,
15 THE AUTHORITY MAY, WITHIN WEST BALTIMORE COUNTY:

16 (1) ACQUIRE, PURCHASE, OR OTHERWISE OBTAIN, HOLD, AND USE
17 ANY PROPERTY, REAL, PERSONAL, OR MIXED, TANGIBLE OR INTANGIBLE, OR ANY
18 INTEREST THEREIN;

19 (2) LEASE AS A LESSEE ANY PROPERTY, REAL, PERSONAL, OR MIXED,
20 TANGIBLE OR INTANGIBLE, OR ANY INTEREST THEREIN;

21 (3) LEASE AS LESSOR ANY PROPERTY, REAL, PERSONAL, OR MIXED,
22 TANGIBLE OR INTANGIBLE, OR ANY INTEREST THEREIN, AT ANY TIME ACQUIRED BY
23 THE AUTHORITY;

24 (4) MORTGAGE OR OTHERWISE PLEDGE OR ENCUMBER ANY
25 PROPERTY, REAL, PERSONAL, OR MIXED, TANGIBLE OR INTANGIBLE, OR ANY
26 INTEREST THEREIN, OF THE AUTHORITY; AND

27 (5) SELL, TRANSFER, OR CONVEY ANY PROPERTY, REAL, PERSONAL,
28 OR MIXED, TANGIBLE OR INTANGIBLE, OR ANY INTEREST THEREIN, ACQUIRED BY
29 THE AUTHORITY AT ANY TIME.

30 (B) THE AUTHORITY MAY ACCEPT GRANTS FROM, MAKE LOANS TO, AND
31 ENTER INTO CONTRACTS WITH ANY FEDERAL, STATE, OR LOCAL AGENCY OR ANY
32 PRIVATE ENTITY OR PARTY.

1 (C) THE AUTHORITY MAY ESTABLISH, IMPOSE, AND COLLECT TOLLS,
2 RATES, RENTALS, FEES, AND CHARGES RELATING TO THE AUTHORITY'S
3 UNDERTAKINGS AND PROPERTY.

4 (D) THE BUDGETARY AND FINANCIAL PROCEDURES OF THE AUTHORITY
5 SHALL BE ESTABLISHED BY LOCAL LAW.

6 (E) NO PROVISIONS OF THE CHARTER OF THE COUNTY OR OTHER LOCAL
7 LAW REGARDING THE DUTIES, POWERS, OR ORGANIZATION OF THE AUTHORITY
8 APPLY TO THE AUTHORITY UNLESS THE COUNTY EXPRESSLY PROVIDES BY LOCAL
9 LAW THAT THE CHARTER PROVISION OR OTHER LOCAL LAW APPLIES TO THE
10 AUTHORITY.

11 (F) SUBJECT TO PUBLIC GENERAL LAW AND LOCAL LAW, THE AUTHORITY
12 HAS ALL OTHER POWERS NECESSARY OR CONVENIENT TO CARRY OUT THE
13 PURPOSES OF THE AUTHORITY.

14 12-808.

15 THE AUTHORITY MAY NOT BE DEEMED A MUNICIPAL CORPORATION AS
16 DEFINED IN ARTICLE XI-E OF THE MARYLAND CONSTITUTION.

17 12-809.

18 (A) THE AUTHORITY MAY MAKE RULES AND REGULATIONS FOR THE
19 OPERATION AND USE OF LAND, PROPERTY, AND UNDERTAKINGS UNDER THE
20 AUTHORITY'S JURISDICTION IN THE MANNER PROVIDED BY LOCAL LAW.

21 (B) ANY VIOLATION OF THE RULES AND REGULATIONS DULY ADOPTED BY
22 THE AUTHORITY IS A MISDEMEANOR AND IS PUNISHABLE BY A FINE NOT TO EXCEED
23 \$1,000 OR IMPRISONMENT FOR NOT MORE THAN 180 DAYS OR BOTH.

25 (A) IN ORDER TO FINANCE OR REFINANCE, IN WHOLE OR IN PART, THE COST
26 OF ACQUISITION, DEVELOPMENT, OR REDEVELOPMENT, INCLUDING THE
27 COMPREHENSIVE RENOVATION OR REHABILITATION, OF LAND OR PROPERTY FOR
28 RESIDENTIAL, COMMERCIAL, OR INDUSTRIAL PURPOSES AND RELATED ACTIVITIES
29 IN ACCORDANCE WITH THIS SUBTITLE, THE AUTHORITY MAY ISSUE BONDS.

30 (B) (1) THE BONDS:

31 (I) MAY NOT CONSTITUTE A DEBT OF THE COUNTY OR A PLEDGE

1 OF THE FAITH AND CREDIT OF THE COUNTY, THE STATE, OR ANY POLITICAL
2 SUBDIVISION OF THE STATE;

3 (II) MAY NOT BE CONSIDERED OBLIGATIONS OF THE COUNTY
4 FOR PURPOSES OF ANY DEBT LIMITATION IMPOSED ON THE COUNTY UNDER ANY
5 CONSTITUTIONAL, STATUTORY, OR OTHER CHARTER PROVISION; AND

6 (III) SHALL BE APPROVED BY THE GOVERNING BODY OF THE
7 COUNTY PRIOR TO THEIR ISSUANCE.

(I) (1) UNLESS THE BONDS ARE GUARANTEED BY AND UPON THE FULL FAITH AND CREDIT OF THE COUNTY AND ARE APPROVED IN A REFERENDUM BY THE VOTERS OF THE COUNTY IN ACCORDANCE WITH SUBSECTION (E) OF THIS SECTION, THE AUTHORITY MAY NOT ISSUE BONDS UNDER THIS SECTION UNTIL AFTER THE AUTHORITY HAS HELD A PUBLIC HEARING IN THE COUNTY ON THE PROPOSED BONDS.

(2) THE AUTHORITY SHALL NOTIFY THE BALTIMORE COUNTY DELEGATIONS OF THE HOUSE OF DELEGATES AND THE SENATE OF MARYLAND OF A PROPOSED ISSUANCE OF BONDS AT LEAST 2 WEEKS BEFORE HOLDING THE PUBLIC HEARING REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION.
