# **A BILL**

To authorize the Georgetown African American Historic Landmark Project and Tour to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Enslaved Voyages Memo-*  
 5 *rial Act”.*

6 **SEC. 2. AUTHORIZATION TO ESTABLISH COMMEMORATIVE**  
 7 **WORK.**

8 *(a) IN GENERAL.—The Georgetown African American*  
 9 *Historic Landmark Project and Tour may establish a com-*  
 10 *memorative work on Federal land in the District of Colum-*  
 11 *bia and its environs to commemorate the enslaved individ-*  
 12 *uals, whose identities may be known or unknown, who en-*  
 13 *dured the Middle Passage.*

14 *(b) COMPLIANCE WITH STANDARDS FOR COMMEMORA-*  
 15 *TIVE WORKS.—The establishment of the commemorative*  
 16 *work under this section shall be in accordance with chapter*  
 17 *89 of title 40, United States Code (commonly known as the*  
 18 *“Commemorative Works Act”).*

19 *(c) PROHIBITION ON THE USE OF FEDERAL FUNDS.—*

20 *(1) IN GENERAL.—Federal funds may not be*  
 21 *used to pay any expense of the establishment of the*  
 22 *commemorative work under this section.*

23 *(2) RESPONSIBILITY OF THE GEORGETOWN AFRI-*  
 24 *CAN AMERICAN HISTORIC LANDMARK PROJECT AND*  
 25 *TOUR.—The Georgetown African American Historic*

1     *Landmark Project and Tour shall be solely respon-*  
2     *sible for acceptance of contributions for, and payment*  
3     *of the expenses of, the establishment of the commemo-*  
4     *rative work under this section.*

5     *(d) DEPOSIT OF EXCESS FUNDS.—*

6             *(1) IN GENERAL.—If upon payment of all ex-*  
7     *penses for the establishment of the memorial (includ-*  
8     *ing the maintenance and preservation amount re-*  
9     *quired by section 8906(b)(1) of title 40, United States*  
10    *Code), there remains a balance of funds received for*  
11    *the establishment of the commemorative work, the*  
12    *Georgetown African American Historic Landmark*  
13    *Project and Tour shall transmit the amount of the*  
14    *balance to the Secretary of the Interior for deposit in*  
15    *the account provided for in section 8906(b)(3) of title*  
16    *40, United States Code.*

17            *(2) ON EXPIRATION OF AUTHORITY.—If upon ex-*  
18    *piration of the authority for the commemorative work*  
19    *under section 8903(e) of title 40, United States Code,*  
20    *there remains a balance of funds received for the es-*  
21    *tablishment of the commemorative work, the George-*  
22    *town African American Historic Landmark Project*  
23    *and Tour shall transmit the amount of the balance to*  
24    *a separate account with the National Park Founda-*  
25    *tion for memorials, to be available to the Secretary of*

1        *the Interior or Administrator (as appropriate) fol-*  
2        *lowing the process provided in section 8906(b)(4) of*  
3        *title 40, United States Code, for accounts established*  
4        *under section 8906(b)(2) or (3) of title 40, United*  
5        *States Code.*
