1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION OF EL PASO COMMUNITY HEAL-**
4 **ING GARDEN NATIONAL MEMORIAL.**

5 (a) DESIGNATION.—The Healing Garden located at
6 6900 Delta Drive, El Paso, Texas, is designated as the
7 “El Paso Community Healing Garden National Memo-
8 rial”.

9 (b) EFFECT OF DESIGNATION.—The national memo-
10 rial designated by this section is not a unit of the National
11 Park System and the designation of the El Paso Commu-
12 nity Healing Garden National Memorial shall not require
13 or authorize Federal funds to be expended for any purpose
14 related to that national memorial.
