9 *the Homeland Security Act of 2002 (6 U.S.C. 621 et seq.),*

12 *(Public Law 113–254), shall continue in effect through the*
13 *date specified in section 105(3).*

14 “*SEC. 139. Section 319L(e)(1)(A) of the Public Health*
15 *Service Act (42 U.S.C. 247d–7e(e)(1)(A)) shall continue in*
16 *effect through the date specified in section 105(3) of this*
17 *Act.*

18 “*SEC. 140. Section 405(a) of the Pandemic and All*

 19 period at the end and inserting “; and”; and

20 (C) by adding at the end the following:

21 “(F) subject to paragraph (3), \$112,000,000
 22 for fiscal year 2019.”;

23 (2) in paragraph (2)—

1 (A) by striking “Amounts made” and in-
 2 serting “Subject to paragraph (3), amounts
 3 made”; and

4 (B) by striking “September 30, 2016” and
 5 inserting “September 30, 2021”; and

6 (3) by adding at the end the following new para-
 7 graph:

8 “(3) *SPECIAL RULE FOR FY 2019.—Funds ap-*
 9 *propriated under paragraph (1)(F) shall be made*
 10 *available for grants to States only if such States have*
 11 *an approved MFP demonstration project under this*
 12 *section as of December 31, 2018.”.*

13 (b) *FUNDING FOR QUALITY ASSURANCE AND IMPROVE-*
 14 *MENT; TECHNICAL ASSISTANCE; OVERSIGHT.—Section*

12 (b) *RULE OF CONSTRUCTION*.—

13 (1) *PROTECTING STATE SPOUSAL INCOME AND*

11 (B) *A plan amendment to provide medical*
12 *assistance for home and community-based serv-*
13 *ices for individuals by reason of being deter-*
14 *mined eligible under section 1902(a)(10)(C) of*
15 *such Act (42 U.S.C. 1396a(a)(10)(C)) or by rea-*
16 *son of section 1902(f) of such Act (42 U.S.C.*
17 *1396a(f)) or otherwise on the basis of a reduction*
18 *of income based on costs incurred for medical or*
19 *other remedial care under which the State dis-*
20 *regarded the income and assets of the individ-*
21 *ual's spouse in determining the initial and ongo-*
22 *ing financial eligibility of an individual for such*
23 *services in place of the spousal impoverishment*
24 *provisions applied under section 1924 of such*
25 *Act (42 U.S.C. 1396r–5).*

1 (C) *A plan amendment to provide medical*
 2 *assistance for home and community-based at-*
 3 *tendant services and supports under section*
 4 *1915(k) of such Act (42 U.S.C. 1396n(k)).*

5 **SEC. 103. REDUCTION IN FMAP AFTER 2020 FOR STATES**
 6 **WITHOUT ASSET VERIFICATION PROGRAM.**

7 *Section 1940 of the Social Security Act (42 U.S.C.*
 8 *1396w) is amended by adding at the end the following new*
 9 *subsection:*

10 “(k) *REDUCTION IN FMAP AFTER 2020 FOR NON-*
 11 *COMPLIANT STATES.*—

12 “(1) *IN GENERAL.*—*With respect to a calendar*
 13 *quarter beginning on or after January 1, 2021, the*
 14 *Federal medical assistance percentage otherwise deter-*
 15 *mined under section 1905(b) for a non-compliant*
 16 *State shall be reduced—*

17 “(A) *for calendar quarters in 2021 and*
 18 *2022, by 0.12 percentage points;*

19 “(B) *for calendar quarters in 2023, by 0.25*
 20 *percentage points;*

21 “(C) *for calendar quarters in 2024, by 0.35*
 22 *percentage points; and*

23 “(D) *for calendar quarters in 2025 and*
 24 *each year thereafter, by 0.5 percentage points.*

1 “(2) *NON-COMPLIANT STATE DEFINED.*—For
 2 purposes of this subsection, the term ‘non-compliant
 3 State’ means a State—

4 “(A) that is one of the 50 States or the Dis-
 5 trict of Columbia;

6 “(B) with respect to which the Secretary
 7 has not approved a State plan amendment sub-
 8 mitted under subsection (a)(2); and

9 “(C) that is not operating, on an ongoing
 10 basis, an asset verification program in accord-
 11 ance with this section.”.

12 **SEC. 104. MEDICAID IMPROVEMENT FUND.**

13 Section 1941(b)(1) of the Social Security Act (42
 14 U.S.C. 1396w–1(b)(1)) is amended by striking
 15 “\$31,000,000” and inserting “\$6,000,000”.

16 **SEC. 105. BUDGETARY EFFECTS.**

17 (a) *STATUTORY PAYGO SCORECARDS.*—The budgetary
 18 effects of this division shall not be entered on either PAYGO
 19 scorecard maintained pursuant to section 4(d) of the Statu-
 20 tory Pay-As-You-Go Act of 2010 (2 U.S.C. 933(d)).

21 (b) *SENATE PAYGO SCORECARDS.*—The budgetary ef-
 22 fects of this division shall not be entered on any PAYGO
 23 scorecard maintained for purposes of section 4106 of H.
 24 Con. Res. 71 (115th Congress).

1 (c) *CLASSIFICATION OF BUDGETARY EFFECTS.*—Not-
 2 withstanding Rule 3 of the Budget Scorekeeping Guidelines
 3 set forth in the joint explanatory statement of the committee
 4 of conference accompanying Conference Report 105–217
 5 and section 250(c)(8) of the Balanced Budget and Emer-
 6 gency Deficit Control Act of 1985, the budgetary effects of
 7 this division shall not be estimated—

8 (1) for purposes of section 251 of such Act; and
 9 (2) for purposes of paragraph (4)(C) of section
 10 3 of the Statutory Pay-As-You-Go Act of 2010 as
 11 being included in an appropriation Act.

12 (d) *PAYGO ANNUAL REPORT.*—For the purposes of
 13 the annual report issued pursuant to section 5 of the Statu-
 14 tory Pay-As-You-Go Act of 2010 (2 U.S.C. 934) after ad-

 16 for determining whether a sequestration order is necessary

 19 *canes, typhoons, volcanic activity, and wildfires occurring*
 20 *in calendar year 2018 under such terms and conditions as*
 21 *determined by the Secretary: Provided, That the Secretary*
 22 *where authorized may provide assistance for such losses in*
 23 *the form of block grants to eligible states and territories and*
 24 *such assistance may include compensation to producers, as*
 25 *determined by the Secretary, for forest restoration and poul-*

1 *try and livestock losses: Provided further, That in the case*
2 *of producers impacted by volcanic activity that resulted in*
3 *the loss of crop land, or access to crop land, the Secretary*
4 *shall consider all measures available, as appropriate, to*
5 *bring replacement land into production: Provided further,*
6 *That the total amount of payments received under this*
7 *heading and applicable policies of crop insurance under the*
8 *Federal Crop Insurance Act (7 U.S.C. 1501 et seq.) or the*
9 *Noninsured Crop Disaster Assistance Program (NAP)*
10 *under section 196 of the Federal Agriculture Improvement*
11 *and Reform Act of 1996 (7 U.S.C. 7333) shall not exceed*
12 *85 percent of the loss as determined by the Secretary: Pro-*
13 *vided further, That the total amount of payments received*
14 *under this heading for producers who did not obtain a pol-*

 3 *Provided, That such amount is designated by the Congress*
 4 *as being for an emergency requirement pursuant to section*
 5 *251(b)(2)(A)(i) of the Balanced Budget and Emergency*
 6 *Deficit Control Act of 1985: Provided further, That the Na-*
 7 *tional Oceanic and Atmospheric Administration shall sub-*
 8 *mit a spending plan to the Committees on Appropriations*
 9 *of the House of Representatives and the Senate within 45*
 10 *days after the date of enactment of this Act.*

11 *FISHERY DISASTER ASSISTANCE*

12 *For an additional amount for “Fishery Disaster As-*
 13 *sistance” for necessary expenses associated with the mitiga-*
 14 *tion of fishery disasters, \$82,000,000, to remain available*
 15 *until expended: Provided, That funds shall be used for miti-*
 16 *gating the effects of commercial fishery failures and fishery*
 17 *resource disasters declared by the Secretary of Commerce,*
 18 *as well as those declared by the Secretary to be a direct*
 19 *result of Hurricanes Florence and Michael and Typhoons*
 20 *Yutu and Mangkhut: Provided further, That such amount*
 21 *is designated by the Congress as being for an emergency*
 22 *requirement pursuant to section 251(b)(2)(A)(i) of the Bal-*

9 shall be transferred, in aggregate, to “Department of Hous-
10 ing and Urban Development—Program Office Salaries and

12 necessary costs, including information technology costs, of

14 ture of amounts under this heading: Provided further, That
15 the amount specified in the preceding proviso shall be com-
16 bined with funds appropriated under the same heading and

 18 *mitigation funding provided under the heading “Depart-*

 22 *sponse to Hurricane Matthew may be used interchangeably*
 23 *and without limitation for the same activities in the most*
 24 *impacted and distressed areas related to Hurricane Flor-*
 25 *ence. In addition, any funds provided under the heading*

1 “Department of Housing and Urban Development—Com-
2 munity Planning and Development—Community Develop-
3 ment Fund” in this Act or in division I of Public Law
4 115–254 that are allocated in response to Hurricane Flor-
5 ence may be used interchangeably and without limitation

10 the use of funds related to Hurricane Matthew that expand

22 *GENERAL PROVISIONS—THIS DIVISION*

23 *SEC. 1101. Each amount appropriated or made avail-*

1 *SEC. 1102. No part of any appropriation contained*
2 *in this division shall remain available for obligation beyond*

18 *ages caused by the storm at any time during the entirety*

20 *Hurricane Center.*

21 *SEC. 1106. Any amount appropriated by this division,*
22 *designated by the Congress as an emergency requirement*
23 *pursuant to section 251(b)(2)(A)(i) of the Balanced Budget*
24 *and Emergency Deficit Control Act of 1985 and subse-*
25 *quently so designated by the President, and transferred pur-*

1 *suant to transfer authorities provided by this division shall*
2 *retain such designation.*

3 *This division may be cited as the “Additional Supple-*
4 *mental Appropriations for Disaster Relief, 2019”.*
