Of inquiry requesting the President and directing the Attorney General to transmit, respectively, certain documents to the House of Representatives relating to the actions of former Federal Bureau of Investigation Acting Director Andrew McCabe.

1 tives, not later than 14 days after the date of the adoption
 2 of this resolution, copies of any document, record, audio
 3 recording, memorandum, correspondence, or other com-
 4 munication in his possession, or any portion thereof, that
 5 refers or relates to the following:

6 (1) Any meetings or discussions between or
 7 among Deputy Attorney General Rod Rosenstein
 8 and former Federal Bureau of Investigation (FBI)
 9 Acting Director Andrew McCabe, regarding con-
 10 versations with the President, including but not lim-
 11 ited to—

12 (A) any reference concerning wearing a re-
 13 cording device or preparing in any way to
 14 record the President; and

15 (B) any reference concerning the invoca-
 16 tion of the 25th Amendment of the U.S. Con-
 17 stitution to remove the President from office.

18 (2) Any meetings or discussions between or
 19 among FBI Acting Director Andrew McCabe and
 20 others at the FBI referring or relating to com-
 21 mencing or continuing an obstruction of justice or
 22 counterintelligence investigation of the President.

23 *That the Attorney General of the United States is directed*
 24 *to transmit, to the House of Representatives, not later than*
 25 *14 days after the date of the adoption of this resolution,*

1 *copies of any document, record, audio recording, memo-*
2 *randum, correspondence, or other communication in his*
3 *possession, or any portion thereof, that refers or relates to*
4 *the following:*

5 (1) *Any meetings or discussions between or*
6 *among Deputy Attorney General Rod J. Rosenstein*
7 *and former Federal Bureau of Investigation (FBI)*
8 *Acting Director Andrew McCabe, regarding conversa-*
9 *tions with the President, including but not limited*
10 *to—*

11 (A) *any reference concerning wearing a re-*
12 *cording device or preparing in any way to*
13 *record the President; and*

14 (B) *any reference concerning the invocation*
15 *of the 25th Amendment of the U.S. Constitution*
16 *to remove the President from office.*

17 (2) *Any meetings or discussions between or*
18 *among FBI Acting Director Andrew McCabe and oth-*
19 *ers at the FBI referring or relating to commencing or*
20 *continuing an obstruction of justice or counterintel-*
21 *ligence investigation of the President.*
