A BILL

To amend the Public Health Service Act to authorize certain recovery services grants to be used to establish regional technical assistance centers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Peer Support Commu-
- 5 nities of Recovery Act".
- 6 SEC. 2. BUILDING COMMUNITIES OF RECOVERY.
- 7 Section 547 of the Public Health Service Act (42
- 8 U.S.C. 290ee-2) is amended—
- 9 (1) in subsection (a)—

1	(A) in the heading, by striking "Defini-
2	TION" and inserting "DEFINITIONS";
3	(B) in the matter preceding paragraph (1),
4	by striking "In this section, the term recovery
5	community organization' means an independent
6	nonprofit organization that—" and inserting
7	"In this section:";
8	(C) by redesignating paragraphs (1) and
9	(2) as subparagraphs (A) and (B), respectively,
10	and moving such subparagraphs (as so redesig-
11	nated) 2 ems to the right;
12	(D) by inserting before subparagraph (A)
13	(as so redesignated) the following:
14	"(1) Recovery community organization.—
15	The term 'recovery community organization' means
16	an independent nonprofit organization that—"; and
17	(E) by adding at the end the following:
18	"(2) ELIGIBLE ENTITY.—The term 'eligible en-
19	tity' means—
20	"(A) a national nonprofit entity focused on
21	substance use disorder with a network of local
22	affiliates and partners that are geographically
23	and organizationally diverse; or
24	"(B) a nonprofit organization—

1	"(i) focused on substance use dis-
2	order;
3	"(ii) established by individuals in per-
4	sonal and family recovery; and
5	"(iii) serving prevention, treatment,
6	recovery, payor, faith-based, and criminal
7	justice stakeholders in the implementation
8	of local addiction and recovery initiatives.";
9	(2) in subsection (b)—
10	(A) by striking "The Secretary shall award
11	grants to recovery community organizations"
12	and inserting "The Secretary—
13	"(1) shall award grants to recovery community
14	organizations";
15	(B) by striking "services." and inserting
16	"services and, at the option of each such orga-
17	nization, carry out the activities described in
18	subparagraphs (A) through (C) of subsection
19	(c)(2); and"; and
20	(C) by adding at the end the following:
21	"(2) may award grants to eligible entities for
22	purposes of establishing regional technical assistance
23	centers, in accordance with subsection $(c)(2)(D)$.";
24	(3) by striking subsection (c);

1	(4) by redesignating subsections (d) and (e) as
2	subsections (c) and (d), respectively;
3	(5) in subsection (c) (as so redesignated)—
4	(A) in paragraph (1), by striking "shall be
5	used" and inserting "to a recovery community
6	organization shall be used"; and
7	(B) in paragraph (2)—
8	(i) in the matter preceding subpara-
9	graph (A), by striking "may be used to—
10	" and inserting "may be used to carry out
11	the activities described in subparagraphs
12	(A) through (C) in the case of a grant
13	awarded to a recovery community organi-
14	zation and to carry out subparagraph (D)
15	in the case of a grant awarded to an eligi-
16	ble entity.";
17	(ii) in subparagraph (A)—
18	(I) in the matter preceding clause
19	(i), by striking "build" and inserting
20	"Build"; and
21	(II) in clause (vii), by striking
22	the semicolon at the end and inserting
23	a period;
24	(iii) in subparagraph (B)—

1	(I) by striking "reduce" and in-
2	serting "Reduce"; and
3	(II) by striking "; and" and in-
4	serting a period;
5	(iv) in subparagraph (C), by striking
6	"conduct" and inserting "Conduct"; and
7	(v) by adding at the end the following:
8	"(D) Provide for the establishment of re-
9	gional technical assistance centers to provide re-
10	gional technical assistance for the following:
11	"(i) Implementation of regionally driv-
12	en, peer-delivered addiction recovery sup-
13	port services before, during, after, or in
14	lieu of addiction treatment.
15	"(ii) Establishment of recovery com-
16	munity organizations.
17	"(iii) Establishment of recovery com-
18	munity centers.
19	"(iv) Overdose reversal medication
20	training and dissemination."; and
21	(6) in subsection (d) (as so redesignated), by
22	inserting before the period the following: ", and
23	\$15,000,000 for each of fiscal years 2019 through
24	2023".
