## A BILL

To authorize major medical facility projects for the Department of Veterans Affairs for fiscal year 2020, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Major Medical Facility  
5 Authorization Act of 2020”.

6 **SEC. 2. AUTHORIZATION OF MAJOR MEDICAL FACILITY**  
7 **PROJECTS OF DEPARTMENT OF VETERANS**  
8 **AFFAIRS FOR FISCAL YEAR 2020.**

9 (a) IN GENERAL.—The Secretary of Veterans Affairs  
10 may carry out the following major medical facility projects

1 in fiscal year 2020 at the locations specified and in an  
2 amount for each project not to exceed the amount speci-  
3 fied for such location:

4 (1) Construction of an outpatient clinic and na-  
5 tional cemetery in Alameda, California, in an  
6 amount not to exceed \$113,332,000.

7 (2) Realignment and closure of the Livermore  
8 Campus in Livermore, California, in an amount not  
9 to exceed \$311,730,000.

10 (3) Construction of a new medical facility in  
11 Louisville, Kentucky, in an amount not to exceed  
12 \$860,000,000.

13 (4) Construction relating to flood recovery of  
14 the medical center in Manhattan, New York, in an  
15 amount not to exceed \$372,600,000.

16 (5) Construction of a spinal cord injury build-  
17 ing with a community living center, including a  
18 parking garage, in San Diego, California, in an  
19 amount not to exceed \$230,840,000.

20 (6) Completion of construction of a medical fa-  
21 cility project, including a parking garage, in San  
22 Juan, Puerto Rico, in an amount not to exceed  
23 \$307,000,000.

1           (7) Construction of a new critical care center in  
2       West Los Angeles, California, in an amount not to  
3       exceed \$75,790,000.

4       (b) AUTHORIZATION OF APPROPRIATIONS.—There is  
5       authorized to be appropriated to the Secretary of Veterans  
6       Affairs for fiscal year 2020 or the year in which funds  
7       are appropriated for the Construction, Major Projects ac-  
8       count, \$2,271,292,000 for the projects authorized in sub-  
9       section (a).
