A BILL

To authorize the Project Safe Neighborhoods Grant Program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Project Safe Neighbor-
- 5 hoods Grant Program Authorization Act of 2017".
- 6 SEC. 2. DEFINITIONS.
- 7 For the purposes of this Act—
- 8 (1) the term "criminal street gangs" has the
- 9 meaning given such term in section 521 of title 18,
- 10 United States Code;

- 1 (2) the term "gang crime" means a felony or
 2 misdemeanor crime, under State or Federal law,
 3 committed by one or more persons who are a mem4 ber of, or directly affiliated with, a criminal street
- 5 gang;
- 6 (3) the term "transnational organized crime 7 group" has the meaning given such term in section 8 36(k)(6) of the State Department Basic Authorities
- 9 Act of 1956 (22 U.S.C. 2708(k)(6));
- 10 (4) the term "transnational organized crime"
- has the meaning given such term in section 36(k)(5)
- of the State Department Basic Authorities Act of
- 13 1956 (22 U.S.C. 2708(k)(5)); and
- 14 (5) the term "firearms offenses" means an of-
- 15 fense under section 922 or 924 of title 18, United
- 16 States Code.

17 SEC. 3. ESTABLISHMENT.

- 18 The Attorney General of the United States is author-
- 19 ized to establish and carry out a program, to be known
- 20 as the "Project Safe Neighborhoods Block Grant Pro-
- 21 gram" or, in this Act, as the "Program", within the Office
- 22 of Justice Programs at the Department of Justice.
- 23 SEC. 4. PURPOSE.
- 24 The purpose of the Project Safe Neighborhoods Block
- 25 Grant Program shall be to foster and improve existing

- 1 partnerships between Federal, State, and local agencies,
- 2 including the United States Attorney in each Federal judi-
- 3 cial district, to create safer neighborhoods through sus-
- 4 tained reductions in crimes, including violent crimes and
- 5 homicides, committed by criminal street gangs and
- 6 transnational organized crime groups.

7 SEC. 5. RULES AND REGULATIONS.

- 8 (a) In General.—The Attorney General shall, not
- 9 later than 60 days after the date of enactment of this Act,
- 10 make rules to create, carry out, and administer the Pro-
- 11 gram in accordance with this section.
- 12 (b) Funds To Be Directed to Local Control.—
- 13 Amounts made available as grants under the Program
- 14 shall be, to the greatest extent practicable, locally con-
- 15 trolled to address problems that are identified locally
- 16 (c) Regional Gang Task Forces.—20 percent of
- 17 the amounts made available as grants under the Program
- 18 each fiscal year shall be granted to established Regional
- 19 Gang Task Forces in regions experiencing a significant
- 20 or increased presence of, or high levels of activity from,
- 21 transnational organized crime groups posing threats to
- 22 community safety in terms of violent crime, firearms of-
- 23 fenses, human trafficking, trafficking and distribution of
- 24 illegal opioids and heroin, and other crimes.

1 SEC. 6. AUTHORIZATION OF APPROPRIATIONS.

- 2 There is authorized to be appropriated for the Pro-
- 3 gram under this Act \$70,000,000 annually for fiscal years

4 2018 through 2022.
