A BILL

FOR AN ACT ENTITLED

1 **"An Act relating to the Board of Pharmacy; relating to the practice of pharmacy;**
2 **relating to pharmacies; relating to prescription drug manufacturers; relating to**
3 **prescriptions for epinephrine; relating to the administration of epinephrine; and**
4 **providing for an effective date."**

5 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

6 * **Section 1.** AS 08.80.010(a) is amended to read:

7 (a) There is created the Board of Pharmacy, composed of seven members, five
8 of whom shall be pharmacists licensed in the state who have been actively engaged in
9 the practice of pharmacy in the state for a period of three years immediately preceding
10 their appointment. **One shall be a pharmacy technician licensed in the state for a**
11 **period of two years immediately preceding appointment. One** [TWO] shall be **a**
12 **person** [PERSONS] with no direct financial interest in the health care industry.
13 Whenever possible, the board shall include at least one member from each judicial
14 district.

1 * **Sec. 2.** AS 08.80.030(b) is amended to read:

2 (b) In order to fulfill its responsibilities, the board has the powers necessary
3 for implementation and enforcement of this chapter, including the power to

4 (1) elect a president and secretary from its membership and adopt rules
5 for the conduct of its business;

6 (2) license by examination or by license transfer the applicants who are
7 qualified to engage in the practice of pharmacy;

8 (3) assist the department in inspections and investigations for
9 violations of this chapter, or of any other state or federal statute relating to the practice
10 of pharmacy;

11 (4) adopt regulations to carry out the purposes of this chapter;

12 (5) establish and enforce compliance with professional standards and
13 rules of conduct for pharmacists engaged in the practice of pharmacy;

14 (6) determine standards for recognition and approval of degree
15 programs of schools and colleges of pharmacy whose graduates shall be eligible for
16 licensure in this state, including the specification and enforcement of requirements for
17 practical training, including internships;

18 (7) establish for pharmacists and pharmacies minimum specifications
19 for the physical facilities, technical equipment, personnel, and procedures for the
20 storage, compounding, and dispensing of drugs or related devices, and for the
21 monitoring of drug therapy, including independent monitoring of drug therapy;

22 (8) enforce the provisions of this chapter relating to the conduct or
23 competence of pharmacists practicing in the state, and the suspension, revocation, or
24 restriction of licenses to engage in the practice of pharmacy;

25 (9) license and regulate the training, qualifications, and employment of
26 pharmacy interns and pharmacy technicians;

27 (10) **license and regulate the qualifications of entities and**
28 **individuals** [ISSUE LICENSES TO PERSONS] engaged in the manufacture **or**
29 [AND] distribution of drugs and related devices;

30 (11) establish and maintain a controlled substance prescription
31 database as provided in AS 17.30.200;

(12) establish standards for the independent prescribing and administration of vaccines and related emergency medications under AS 08.80.168, including the completion of an immunization training program approved by the board **and an epinephrine auto-injector training program under AS 17.22.020(b);**

(13) establish standards for the independent prescribing and dispensing by a pharmacist of an opioid overdose drug under AS 17.20.085, including the completion of an opioid overdose training program approved by the board;

(14) require that a licensed pharmacist **who dispenses a schedule II, III, or IV controlled substance under federal law to a person in the state** register with the controlled substance prescription database under AS 17.30.200(n);

(15) establish the qualifications and duties of the executive administrator and delegate authority to the executive administrator that is necessary to conduct board business;

(16) license and inspect the facilities of **pharmacies, manufacturers,** wholesale drug distributors, third-party logistics providers, and outsourcing facilities located outside the state under AS 08.80.159;

(17) license Internet-based pharmacies providing services to residents in the state;

(18) adopt regulations pertaining to retired pharmacist status.

* **Sec. 3.** AS 08.80.145 is amended to read:

Sec. 08.80.145. Reciprocity; license transfer. If another jurisdiction allows licensure in that jurisdiction of a pharmacist licensed in this state under conditions similar to those in this section, the board may license as a pharmacist in this state a person licensed as a pharmacist in the other jurisdiction if the person

(1) submits a written application to the board on a form required by the board;

(2) is at least 18 years of age;

(3) [IS OF GOOD MORAL CHARACTER;

(4)] possesses at the time of the request for licensure as a pharmacist in this state the qualifications necessary to be eligible for licensure in this state;

(4) [(5)] has engaged in the practice of pharmacy for at least one year

[OR HAS MET THE INTERNSHIP REQUIREMENTS OF THIS STATE WITHIN THE ONE-YEAR PERIOD] immediately before applying for a license under this section;

(5) [(6)] presents proof satisfactory to the board that the person is currently licensed as a pharmacist in the other jurisdiction and does not currently have a pharmacist license suspended, revoked, or otherwise restricted except for failure to apply for renewal or failure to obtain the required continuing education credits;

(6) [(7)] has passed an examination approved by the board that tests the person's knowledge of Alaska laws relating to pharmacies and pharmacists and the regulations adopted under those laws; and

(7) [(8)] pays all required fees.

(k) This section applies to **pharmacies, manufacturers,** wholesale drug distributors, third-party logistics providers, and outsourcing facilities located outside the state under AS 08.80.159.

* **Sec. 5.** AS 08.80.159(a) is amended to read:

(a) Before shipping, mailing, **distributing,** or delivering **a** prescription **drug** [DRUGS] to a **person** [LICENSEE] in the state or advertising in the state, a **pharmacy, manufacturer,** wholesale drug distributor, third-party logistics provider, or an outsourcing facility that is located outside the state shall

(1) obtain a license under AS 08.80.157;

(2) appoint an agent on whom process can be served in the state; and

(3) authorize inspection of the facility by a designee of the board under (c) of this section.

Sec. 17.22.010. Prescription, purchase, and administration of epinephrine by a trained individual. An individual who is 18 years of age or older may obtain a prescription for, purchase, and, in an emergency situation, administer epinephrine **to another person** using

[(1)] an auto-injector, if the individual has successfully completed a training program approved by the **board** [DEPARTMENT] under as 17.22.020(b) [; OR

(2) AN AMPULE, IF THE INDIVIDUAL HAS SUCCESSFULLY COMPLETED A TRAINING PROGRAM APPROVED BY THE DEPARTMENT UNDER AS 17.22.020(c)].

(a) The **board** [DEPARTMENT] shall adopt standards for the approval of **a** training **program** [PROGRAMS] for the use of

(b) The **board** [DEPARTMENT] shall approve an auto-injector training program that meets standards adopted under **(a)** [(a)(1)] of this section. The standards must require an epinephrine auto-injector program to provide training in

(1) techniques on how to recognize symptoms of severe asthmatic or allergic reactions, including anaphylaxis;

(2) standards and procedures for the storage of epinephrine auto-

1 injectors and administration of epinephrine using auto-injectors; and

2 (3) emergency follow-up procedures.
