

5 6	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
7	Article – Health – General

9 10 11	(a) (1) Except as provided in subsection (d) of this section, an assisted living manager who is employed by an assisted living program shall have completed a manager training course that is approved by the Department and includes an examination.
12	(2) The manager training course shall:
13	(i) Consist of at least 80 hours; AND
14 15	(ii) [Require attendance or participation at training programs that provide for direct interaction between faculty and participants; and
