## A BILL

To amend the Housing Act of 1949 to permit the assumption of loans under the Doug Bereuter Section 502 Single Family Housing Loan Guarantee Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Rural Homeownership
- 5 Continuity Act of 2024".

| 14 | "(B) Release from liability.—If a bor-                 |
| 15 | rower of a guaranteed loan under this sub-             |
| 16 | section transfers the property for which the           |
| 17 | guaranteed loan was made to an individual who          |
| 18 | assumes the guaranteed loan under subpara-             |
| 19 | graph (A), the transferor, and any co-borrower         |
| 20 | or guarantor of the transferor, shall be relieved      |
| 21 | of liability with respect to the guaranteed loan.      |
| 22 | "(C) Assumption of obligations,                        |
| 23 | RIGHTS, AND INTERESTS.—The Secretary shall             |
| 24 | provide in each assumption under subparagraph          |
| 25 | (A) for the assumption of the obligations,             |
| 26 | rights, and interests under the terms of the           |

- 1 guaranteed loan or such other terms as the Sec-
- 2 retary determines appropriate.".
