The term of a member is 4 years. 8 (c) (1) 9 **(2)** The terms of members are staggered as required by the terms provided for members of the board on October 1, 2002. 10 11 (3)At the end of a term, a member continues to serve until a successor is 12appointed and qualifies. 13 A member who is appointed after a term has begun serves only for the 14 rest of the term and until a successor is appointed and qualifies. 15 (d) The board may recommend to the county commissioners: 16 (1) the types of gaming devices that may be operated in the county; 17 (2) approval or denial of a gaming permit; and (3) modifications of the county gaming regulations and procedures. 18 19 (e) The board shall: 20 (1) review at least quarterly gaming permit applications; review gaming regulations and permit procedures; 21 (2) 22 keep a list of all approved lessors of gaming devices and premises for (3) 23gaming events; 24keep a record of the gaming permits that the board has reviewed; and **(4)** 25undertake the other duties regarding gaming regulation that the (5)26 county commissioners delegate.

As the county commissioners consider appropriate, the county commissioners

shall provide for the board a clerk, legal counsel, supplies, and funding.

At least 30 days before the first day of the calendar quarter in which 1 (c) (1) 2 the gaming event is to be conducted, a fundraising organization seeking a gaming permit 3 shall submit to the [board] **COUNTY ATTORNEY** an application and the application fee. 4 (2)The application shall contain the following: any other information that the [board] COUNTY ATTORNEY 5 6 considers necessary or helpful. 7 (e) (1) The [board] **COUNTY ATTORNEY** shall: 8 review the gaming permit applications for a calendar quarter 9 within 10 days after the application deadline set in subsection (c)(1) of this section; 10 (ii) recommend approval or denial of each application; and 11 promptly forward the applications and recommendations to the (iii) 12 county commissioners. 13 This section does not prevent the [board] COUNTY ATTORNEY or the (3)14 county commissioners from reviewing gaming permit applications more frequently or earlier than required by this subsection. 15 16 13–1107. 17 (a) (6)A fundraising organization may lease gaming devices or premises for a 18 gaming event only from a fundraising organization that the [board] COUNTY ATTORNEY 19 approves. Notwithstanding subparagraph (i) of this paragraph, a 20 (9)(iii) 21fundraising organization that conducts a gaming event at the Charles County Fair in 22conjunction with the Charles County Fair Board may conduct the gaming event under a 23single gaming permit for more than 48 hours, subject to regulations that the county 24commissioners adopt on recommendation of the [board] COUNTY ATTORNEY. 25(b) A fundraising organization that has conducted a gaming event shall 26 submit a report to the [board] COUNTY ATTORNEY within 30 days after the end of the calendar quarter in which the gaming event was conducted. 27 28 (2) The report shall contain: 29 the date, amount, nature, source, and recipient of each receipt

- 1 (ix) any other information that the [board] COUNTY ATTORNEY 2 considers necessary or helpful.
- 3 (c) A fundraising organization that conducts a gaming event shall maintain 4 accurate records of each transaction concerning the gaming event, and shall keep the 5 records available for examination by the [board] **COUNTY ATTORNEY** and the county 6 commissioners for 3 years after the gaming event.
- SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2025.
