Critical Medical Needs Program Expansion Pilot Program - Social Services

- 3 FOR the purpose of establishing the Critical Medical Needs Program Expansion Pilot 4 Program in the Department of Human Services; stating that the purpose of the Pilot 5 Program is to provide assistance to certain critical medically vulnerable individuals 6 and their households with the application process for certain social services in Baltimore County and the City of Baltimore; requiring the Department to implement 7 8 and administer the Pilot Program in partnership with certain agencies and 9 organizations; establishing the qualifications for assistance under the Pilot Program; 10 prohibiting the Department from requiring a certain critical medically vulnerable 11 individual to provide certain additional documentation to qualify for assistance; 12 requiring the Pilot Program to assist certain individuals with the application process for 13 certain social services through certain navigators; requiring the Department to 14 establish training requirements for certain navigators, provide or facilitate certain 15 training, develop a certain database and establish a certain tracking system, create 16 certain administrative positions, report annually to the General Assembly on or before 17 a certain date, and adopt certain regulations; defining certain terms; providing for the 18 termination of this Act; and generally relating to the Critical Medical Needs Program 19 Expansion Pilot Program.

- 18 THE DEPARTMENT SHALL PARTNER WITH THE OFFICE OF PEOPLE'S COUNSEL, THE
- 19 FUEL FUND OF CENTRAL MARYLAND, THE CANCER SUPPORT FOUNDATION, OTHER
- 20 STATE AGENCIES, AND ANY OTHER ORGANIZATION THAT THE DEPARTMENT
- 21 DETERMINES APPROPRIATE.
- 22 (C) (1) TO QUALIFY FOR ASSISTANCE UNDER THE CMNP EXPANSION
- 23 PILOT PROGRAM, A CRITICAL MEDICALLY VULNERABLE INDIVIDUAL MUST:
- 24 (I) BE RECEIVING OR HAVE RECEIVED ASSISTANCE FROM A
- 25 NAVIGATOR UNDER THE CMN PROGRAM; AND
- 26 (II) BE UNABLE TO COMPLETE THE APPLICATIONS FOR
- 27 AVAILABLE SOCIAL SERVICES.
- 28 (2) THE DEPARTMENT MAY NOT REQUIRE A CRITICAL MEDICALLY
- 29 VULNERABLE INDIVIDUAL TO PROVIDE ANY ADDITIONAL DOCUMENTATION OF
- 30 MEDICAL NEED TO QUALIFY FOR ASSISTANCE UNDER THE CMNP EXPANSION PILOT

(2) THE DEPARTMENT SHALL:

- 6 (I) ESTABLISH TRAINING REQUIREMENTS FOR NAVIGATORS
 7 AND PUBLISH THE REQUIREMENTS ON THE DEPARTMENT'S WEBSITE;
- 8 (II) TRAIN NAVIGATORS OR FACILITATE THE TRAINING OF 9 NAVIGATORS BY OTHERS ON AN ONGOING BASIS;
- 10 (III) DEVELOP A DATABASE AND ESTABLISH A TRACKING SYSTEM
 11 TO MONITOR THE STATUS OF APPLICATIONS FOR SOCIAL SERVICES FOR CRITICAL
 12 MEDICALLY VULNERABLE INDIVIDUALS WHO PARTICIPATE IN THE CMNP
 13 EXPANSION PILOT PROGRAM; AND
- 14 (IV) CREATE ONE FULL-TIME POSITION AND ONE PART-TIME 15 POSITION TO PROVIDE ADMINISTRATIVE SUPPORT TO THE CMNP EXPANSION 16 PILOT PROGRAM.
- 17 (E) ON OR BEFORE OCTOBER 1, 2021, AND EACH OCTOBER 1 THEREAFTER,
 18 THE DEPARTMENT SHALL REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE
 19 WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, ON THE IMPLEMENTATION
 20 OF THE CMNP EXPANSION PILOT PROGRAM.
- 21 **(F)** THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THIS 22 SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2020. It shall remain effective for a period of 3 years and 1 month, and, at the end of October 31, 2023, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
