FOR the purpose of altering the membership of the Kent County Board of Education to include a student member; providing for the initial term of the student member of the county board; and generally relating to the membership of the Kent County Board of Education.
BY repealing and reenacting, with amendments, Article – Education Section 3–801 through 3–803 Annotated Code of Maryland (2022 Replacement Volume)
SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
