A BILL

To amend the Fair Credit Reporting Act to prohibit certain persons from furnishing negative credit information of furloughed employees, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Federal Worker Credit
- 5 Protection Act of 2019".

1	SEC. 2. PROHIBITION ON FURNISHING NEGATIVE CREDIT
2	INFORMATION OF FURLOUGHED EMPLOY-
3	EES.
4	Section 623(a)(1) of the Fair Credit Reporting Act
5	(15 U.S.C. $1681s-2(a)(1)$) is amended by adding at the
6	end the following new subparagraph:
7	"(F) Reporting information of fur-
8	LOUGHED EMPLOYEES.—
9	"(i) In General.—Notwithstanding
10	any other provision of this section and
11	upon request of a furloughed employee, a
12	person that furnishes information to any
13	consumer reporting agency may not pro-
14	vide negative credit information of such
15	furloughed employee to a consumer report-
16	ing agency if the action or inaction to
17	which such negative credit information re-
18	lates originated, and was rectified, during
19	the period beginning 30 days before a
20	shutdown and ending 90 days after such
21	shutdown.
22	"(ii) Notification.—With respect to
23	any negative credit information described
24	in clause (i) and upon request of the fur-
25	loughed employee to which such negative
26	credit information relates, a person that

1	furnishes information to any consumer re-
2	porting agency shall notify a consumer re-
3	porting agency that the action or inaction
4	to which such negative credit information
5	relates occurred during the period de-
6	scribed in clause (i).
7	"(iii) Definitions.—For purposes of
8	this subparagraph—
9	"(I) the term 'furloughed em-
10	ployee' means—
11	"(aa) a Federal or District
12	of Columbia employee who is fur-
13	loughed or excepted from fur-
14	lough during a shutdown; and
15	"(bb) a Federal contractor
16	who, during a shutdown, is not
17	receiving pay by reason of such
18	shutdown; and
19	"(II) the term 'shutdown' means
20	any lapse in appropriations beginning
21	on or about December 22, 2018.".
