18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,					
9	That the Laws of Maryland read as follows:

[Seven] 11 nonpartisan elected members; AND

4 5 6	(i) [One] 1 member shall be elected from each of the seven councilmanic districts in the county, established by the County Council of Baltimore County, by the voters of that district; and
7 8	(ii) [Four] 4 members shall be [appointed by the Governor] ELECTED from the county at large.
9 10	(2) [(i)] The [seven] 11 elected members shall be elected at a general election in accordance with § 3–2B–02 of this subtitle.

(d) 3 (e) Beginning October 1, 2018, for each nomination for a vacancy on the county board, the Commission shall submit to the Governor a list of nominees that contains: 4 5 (1) At least two names for each vacancy; or 6 If there are fewer than two applicants for a vacancy, the number of (2)7 names that is equal to the number of applicants for the vacancy. 8 Absent an extraordinary circumstance, the Governor shall appoint a member to the county board from the list provided by the Commission. 9 10 If the Governor elects not to appoint a member from a list submitted by 11 the Commission, the Governor shall return the list to the Commission and request that the 12 Commission submit the names of additional qualified candidates. SECTION 2. AND BE IT FURTHER ENACTED. That the terms of the four members 13 of the Baltimore County Board of Education appointed under § 3–2B–01 of the Education 14 Article, who are serving on December 1, 2024, shall terminate at the end of December 1, 15 2024, and the members elected from Baltimore County at large at the general election in 16 17 November 2024 shall succeed those appointed members and serve for a term of 4 years 18 beginning December 2, 2024, until a successor is elected and qualifies.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023.
