2 **Baltimore City – Insurance – Certificates of Guarantee for County Bond**
3 **Requirements**

4 FOR the purpose of authorizing Baltimore City to honor certificates of guarantee that are
5 issued by certain associations or on behalf of certain contractors in order to satisfy
6 certain county bond requirements; providing that Baltimore City is not required
7 under certain provisions of law to honor certain certificates of guarantee; and
8 generally relating to Baltimore City and certificates of guarantee.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Insurance**

17 1–203.

18 (a) (1) In this section the following words have the meanings indicated.

19 (2) “Certificate of guarantee” means an instrument that is issued:

(i) by a nonprofit association of contractors, or its wholly owned subsidiary that is approved to operate by **BALTIMORE CITY**, Calvert County, Charles County, Howard County, Prince George's County, Montgomery County, St. Mary's County, or Washington County, as appropriate; and

(ii) on behalf of a contractor for the purpose of satisfying:

1. county bond requirements for public improvements; or

2. other county bond requirements.

(3) "Contractor" means a person that, for a fixed price, commission, fee, or percentage, undertakes to bid on or accepts or offers to accept orders or contracts to perform or supervise the construction, improvement, or maintenance of a building, structure, or road.

(b) This article does not apply to a certificate of guarantee.

(c) **BALTIMORE CITY**, Calvert County, Charles County, Howard County, Montgomery County, Prince George's County, St. Mary's County, and Washington County:

(1) may honor certificates of guarantee; but

(2) are not required under this article to honor certificates of guarantee.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2023.
