3 FOR the purpose of ~~prohibiting a person from knowingly producing plants, or any part of a~~
4 ~~plant, that exceed a certain concentration of delta-8-tetrahydrocannabinol; altering~~
5 ~~the definition of “hemp product” for purposes of certain provisions of law governing~~
6 ~~hemp research and production to exclude certain products made through a process~~
7 ~~that includes the use of hemp; altering the definition of “marijuana” for purposes of~~
8 ~~the Maryland Controlled Dangerous Substances Act to include certain products~~
9 ~~made through a process that includes the use of hemp; defining “medical cannabis”~~
10 ~~for the purposes of provisions of law regulating medical cannabis; requiring the~~
11 Natalie M. LaPrade Medical Cannabis Commission, in consultation with the State
12 Department of Agriculture and representatives of a certain coalition, to study and
13 make recommendations on the classification and regulation of
14 tetrahydrocannabinols, other than delta-9-tetrahydrocannabinol, and certain

~~(IV)~~ (III) EXCEPT FOR RESIN, ANY ANY OTHER COMPOUND, MANUFACTURED PRODUCT, SALT, DERIVATIVE, MIXTURE, OR PREPARATION OF THE MATURE STALKS, FIBER, OIL, OR CAKE;

~~(V)~~ (IV) THE STERILIZED SEED OF THE PLANT THAT IS INCAPABLE OF GERMINATION; OR

[(l)] (M) "Medical cannabis grower agent" means an owner, an employee, a volunteer, an officer, or a director of a grower.

[(m)] (N) "Processor" means an entity that:

(1) Transforms medical cannabis into another product or extract; and

(2) Packages and labels medical cannabis.

1 [(n)] (O) “Processor agent” means an owner, a member, an employee, a
2 volunteer, an officer, or a director of a processor.

3 [(o)] (P) “Qualifying patient” means an individual who:

4 (1) Has been provided with a written certification by a certifying provider
5 in accordance with a bona fide provider–patient relationship; and

6 (2) If under the age of 18 years, has a caregiver.

7 [(p)] (Q) “Written certification” means a certification that:

8 (1) Is issued by a certifying provider to a qualifying patient with whom the
9 provider has a bona fide provider–patient relationship;

10 (2) Includes a written statement certifying that, in the provider’s
11 professional opinion, after having completed an assessment of the patient’s medical history
12 and current medical condition, the patient has a condition:

13 (i) That meets the inclusion criteria and does not meet the exclusion
14 criteria of the certifying provider’s application; and

15 (ii) For which the potential benefits of the medical use of cannabis
16 would likely outweigh the health risks for the patient; and

17 (3) May include a written statement certifying that, in the provider’s
18 professional opinion, a 30–day supply of medical cannabis would be inadequate to meet the
19 medical needs of the qualifying patient.

20 SECTION 2. AND BE IT FURTHER ENACTED, That:

21 (a) The Natalie M. LaPrade Medical Cannabis Commission, in consultation with
22 the State Department of Agriculture and representatives of the Maryland Hemp Coalition,
23 shall study and make recommendations on the classification and regulation of
24 tetrahydrocannabinols, other than delta–9–tetrahydrocannabinol, that are artificially,
25 synthetically, or naturally derived, and manufactured products containing delta–8– and
26 delta–10–tetrahydrocannabinol.

27 (b) On or before January 1, 2023, the Natalie M. LaPrade Medical Cannabis
28 Commission shall report its findings and recommendations to the Governor and, in
29 accordance with § 2–1257 of the State Government Article, the Senate Finance Committee,
30 the Senate Judicial Proceedings Committee, the House Judiciary Committee, and the
31 House Health and Government Operations Committee.

32 SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act is an emergency
33 measure, is necessary for the immediate preservation of the public health or safety, has
34 been passed by a yea and nay vote supported by three–fifths of all the members elected to

1 each of the two Houses of the General Assembly, and shall take effect from the date it is
2 enacted.
