## Public and Nonpublic Schools – Auto–Injectable Epinephrine and Bronchodilators – Use, Availability, Training, and Policies

4 FOR the purpose of requiring each county board of education and authorizing nonpublic 5 schools in the State to update their policies to require certain school nurses and other 6 school personnel to complete certain training before they are authorized to 7 administer auto-injectable epinephrine to a student who is determined to be, or is 8 perceived to be, in anaphylaxis; requiring the State Department of Education, in 9 consultation with certain groups, to identify or develop training for certain school 10 personnel to identify symptoms of anaphylaxis, asthma, and respiratory distress in 11 students; requiring each county board the Maryland Department of Health, in 12 consultation with county boards, and authorizing nonpublic schools in the State to establish a policy to obtain, administer, and train certain school nurses and other 13 14 school personnel to administer in emergency situations bronchodilators to a student who is determined to have asthma, is be or perceived to be experiencing 15 16 asthma-related <del>symptoms,</del> symptoms or is perceived to be in respiratory distress by 17 a school nurse or any other certain designated school personnel; and generally 18 relating to use and availability of auto-injectable epinephrine and bronchodilators 19 in public and nonpublic schools in the State.
