A BILL

To amend the Agricultural Foreign Investment Disclosure Act of 1978 to establish an additional reporting requirement, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "AFIDA Improvements
- 5 Act of 2024".
- 6 SEC. 2. REPORTING; ENFORCEMENT.
- 7 (a) REPORTING REQUIREMENT.—Section 2 of the
- 8 Agricultural Foreign Investment Disclosure Act of 1978

- 1 (7 U.S.C. 3501) is amended by adding at the end the fol-
- 2 lowing:
- 3 "(g) MINIMUM OWNERSHIP.—In the case of agricul-
- 4 tural land in which more than 1 foreign person acquires
- 5 or transfers any interest, other than a security interest,
- 6 the reporting requirements under this section shall apply
- 7 to each foreign person who holds at least a 1 percent inter-
- 8 est in that land—
- 9 "(1) directly through the first tier of ownership;
- 10 or
- 11 "(2) in the aggregate through an interest in
- other entities at various tiers.".

- the Secretary for the effective implementation of

- ommendations made by the report of the Govern-

- to Collect, Track, and Share Key Information Could

18	established by not later than 1 year after the date

23	steps required to establish that process and the
24	elements of that process: and
