# AN ACT

To amend the Homeland Security Act of 2002 to enhance the funding and administration of the Nonprofit Security Grant Program of the Department of Homeland Security, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

- "(2) Establishment of mechanisms to ensure program office processes are conducted in accordance with constitutional, statutory, regulatory, and other legal and agency policy requirements that protect civil rights and civil liberties and, to the maximum extent practicable, advance equity for members of underserved communities.
- "(3) Establishment of mechanisms for the Administrator to provide feedback to eligible nonprofit organizations that do not receive grants.
- "(4) Establishment of mechanisms to collect data to measure the effectiveness of grants under the Program.
- "(5) Establishment and enforcement of standardized baseline operational requirements for States,

(b) REPORT.— (1) In General.—Not later than 180 days after the date of enactment of this Act, the Administrator shall seek to enter into a contract or other agreement with an independent research organization pursuant to which the organization will conduct a study that analyzes and reports on—

- (A) the effectiveness of the Nonprofit Security Grant Program established under section 2009(a) of the Homeland Security Act 2002 (6 U.S.C. 609a(a)), as amended by subsection (a), for preparedness against terrorism and other threats;
- (B) the risk-based formula and allocations under that program; and
- (C) the risk profile of and any identifiable factors leading to the low participation of traditionally underrepresented groups and States under that program.

1 Submission.—The final report required 2 under paragraph (1) shall be submitted to the Com-3 mittee on Homeland Security and Governmental Af-4 fairs of the Senate, the Committee on Homeland Secu-5 rity of the House of Representatives, and the Commit-6 tees on Appropriations of the Senate and the House 7 of Representatives. 8 Funding.—The Administrator may use 9 funding authorized under subsection (j) of section 10 2009 of the Homeland Security Act of 2002 (6 U.S.C. 11 609a)), as amended by subsection (a), to carry out 12 this subsection. 13 (c) Technical and Conforming Amendments.— Section 2008 of the Homeland Security Act of 2002 (6 14 15 *U.S.C.* 609) is amended— 16 (1) in subsection (c) by striking "sections 2003 17 and 2004" and inserting "sections 2003, 2004, and 18 2009"; and 19 (2) in subsection (e), by striking "section 2003 or 20 2004" and inserting "section 2003, 2004, or 2009".
